Introduction

Both of the known Esau Roziers of central Georgia during the Reconstruction Era were born in Pulaski County, Georgia. Their births probably occurred along the banks of Gum Swamp Creek in the northern portion of the county that was put into Bleckley County in 1912. Documentation that conclusively proves the identities of their parents has proved elusive, but evidence indicates that the elder Esau, born about 1826–1827, was the son of [Jacob Rozier Sr.](#) and his wife, Lucinda Rozar. The younger Esau was probably the son of Esau Rozier Sr.

Given their surname and residence in Pulaski County, Georgia in the latter 1860s, the two Esau Roziers were almost certainly enslaved men owned by [Seaborn Rozar](#) or [John Rozar Jr.](#) The Rozar brothers, their siblings, and their children were the only white people with this surname in antebellum Pulaski County. The Rozars all fell into middle-class society, with only Seaborn, John, and John's eldest son, [Robert Rozar](#), owning slaves. Each of them only owned a few enslaved people. After the end of chattel slavery in the United States in 1865, those formerly enslaved by the Rozars either chose or county officials assigned them the surname of "*Rozier*."

The proximity of the residences of the Esau Roziers to Jacob in 1870, and to the relatives of Jonas in the 1870s and 1880s suggests a close connection between them and [Jonas Rozier](#) and [Jacob Rozier Sr.](#), the two enslaved adult males owned by the Rozars in the 1840–1865 period. While no known evidence points to a familial relationship between either of the Esau Roziers to Jonas, the evidence described herein illustrates a connection between the elder Esau and Jacob and Lucinda Rozier.

Esau Rozier & Malinda Wilkinson

The 1880 federal census enumerator recorded Esau Rozier's age as fifty-four years, which would place his birth in about 1828 [1]. The earliest known record of him occurred on 2 April 1867, when the Pulaski County clerk issued a marriage license for "*Esau Rozar Cold*," with "*Cold*" the abbreviation standing for "*colored*," to marry Malinda Wilkinson. The Pulaski County Judge certified that he performed their marriage on April 5th [2]. Later records show that they had children born in the 1850s, and so they may have legalized their relationship in 1867 as soon as black people could legally marry even though it began decades earlier.

On the 1867 and 1868 Pulaski County tax digests, Esau Rozier was listed as a "*Freedman*," the term used to describe formerly enslaved people of African descent during the Reconstruction period. He was employed by Mary C. Coley and only assessed taxes on one poll [3]. Mary was the widow of Jonathan Appleton Drake Coley [4], an exceedingly wealthy man who left her the owner of several thousand acres of land. In 1869, Esau was employed by Mary's brother-in-law, Donaldson Coley [5], while in 1870, his employer was Jonathan A. D. Coley Jr. [6].

The marshal who enumerated the 1870 Pulaski County federal census recorded Esau and Malinda as "*Esau Wright*" and "*Malinda Wright*." Multiple factors allow us to state with certainty that this is our Esau and Malinda Rozier. First, their household adjoined those of Curtis Shines and Hampton Coley, both freedmen that the Coleys employed in 1869–1870 along with Esau Rozier.

Next, a careful comparison of the 1870 household of Esau Wright [7] with the 1880 household of Esau Rosier in Bibb County, Georgia verifies that they are the same. The eldest daughter of Esau and Malinda Wright in 1870 was "*Lucy Wright*," whereas in 1880, "*Lucy Rosier*" was listed as the daughter of Esau and Malinda Rozier. Moreover, the household listed immediately after Esau and Malinda's in both 1870 and 1880 was that of Angeline, a black woman born about 1825–1827. She was listed as "*Anjeline Reagan*" in 1870 and "*Angeline Rosier*" in 1880. Angeline's two youngest children in 1870 were Adam and Betsy "*Rozar*," whereas in 1880, the only two children in her household were Adam and Elizabeth Rosier. Furthermore, the 1870 enumeration included James Reagan, Isaac Reagan, and Alexander Rozar in Angeline's household, presumably her older sons [8]. Twiggs County tax records from 1872 until 1879 show Esau Rozier in the same district as James (Jim), Isaac (Ike), and Alexander (Alec) Rozier.

The reason behind the census marshal recording Esau with the Wright surname in 1870 is unknown, but it is possible he had connections to Jacob Wright, a black man born about 1810 who in 1869 worked for Robert Rozar, son of John Rozar Jr., and in 1870 lived near both the widow of John Rozar Jr. and Seaborn Rozar [9].

Esau Rozier's connection to Angeline and her sons implies that they were siblings, and this ties Esau to [Jacob Rozier Sr.](#) and his wife, Lucinda. During the winter of 1808–1809, [John Rozar Sr.](#) and Daniel Regan settled their families on adjoining farms along Gum Swamp Creek, a tributary of the Ocmulgee River. Between 1809 and 1911, the Rozar and Regan farms lay in the northern portion of Pulaski near its tri-border tip, where Pulaski then intersected Twiggs and Laurens Counties. Rozar's farm lay less than one mile southeast of the Twiggs County border and merely three- or four-miles due west of the Laurens County line. In 1912, this portion of Pulaski County became Bleckley County, where it remains today.

Daniel Regan died in 1827, and appraisers appointed by the Pulaski Court completed an inventory of his estate on 18 October 1827. The enumeration of Regan's individual property listed five slaves, including "*Jacob a negro man*" appraised at \$375, "*Lucy a woman*" valued at \$200, and "*Angeline a Child*" valued at merely \$150 [10]. At the sale of his personal property the next month, Seaborn Rozar paid \$202 for Lucy, while Jacob was purchased by Regan's son-in-law, James Savage. Angelina was not mentioned in the sale [11].

Savage and his wife soon joined the families of Seaborn's sisters and moved to Alabama. Upon his departure from Pulaski County, Savage presumably sold Jacob to Seaborn. It appears that Jacob and Lucy were one of the slave families that Seaborn and his brother, John Rozar Jr., owned over the next three decades [12].

In late 1866, Jacob and Lucinda Rozier, along with Jonas Rozier, Moses Rozier, and Meady Rozar, the son of John Rozar Jr., moved across the county line into Houston County and settled near the county seat of Perry. On 18 January 1867, Jacob, Lucinda, Jonas, and Moses, all described as "*freedmen*," entered into a contract with Faulk in Houston County for the ensuing year. They agreed to follow his directives in cultivating his lands and giving him a share of the harvest in exchange for supplies he furnished them. Since freedmen could not generally read or write, two white witnesses certified that they heard the contract read to the freedmen and saw them make their marks to it. One of the witnesses was [Meady Rozar](#), the third son of John Rozar Jr. Jacob and Lucy would have been well acquainted with Meady, knowing him from the time of his birth in the mid-1830s [13].

These records show that Jacob and Lucy Rozier remained a couple through 1867, probably the parents of Angeline. The 1870 and 1880 federal census enumerations suggest a close connection between Angeline and Esau, a probable indication that they were siblings. This plus the connection of Esau to Angeline's sons in the 1870s implies that Esau was probably the son of Jacob and Lucy.

In late 1870 or 1871, Esau Rozier left the Coley farms near Cochran in Pulaski County and moved northward across the county line into Ware's Militia District of Twiggs County. This location was between five and ten miles from the old farms of Seaborn and John Rozar Jr. in Pulaski County. In 1872, Esau and another freedman, Ike Rozier, cultivated the lands of F. D. Wimberly Sr., a wealthy farmer who employed thirty sharecroppers to cultivate his 2400 acres of land in Twiggs. In 1873, Alexander Rozier joined Esau and Ike in cultivating Wimberly's lands.

The 1874 and 1875 tax digests for Twiggs County show that Esau, Ike, and Jim Rozier still worked as employees of F. D. Wimberly. However, about 1876 or 1877, Esau Rozier left Wimberly's lands and moved further north to Smith's Militia District, located along the Twiggs County border with Bibb County. In 1878, Esau's employer was not listed, but he was assessed taxes for household and kitchen furniture valued at \$5. In 1879, Esau and Jim Rozier worked for R. F. Burkett. Esau was assessed taxes on livestock valued at \$7 and household and kitchen furniture valued at \$10 [14].

After the 1879 harvest, Esau Rozier moved across the county line into Bibb County, Georgia, settling in the region east of Macon. Angeline Rozier and her two youngest children moved with him, and they lived in adjoining households there in 1880 [15]. It is not known what became of Angeline. Esau Rozier died sometime between 1880 and 1900, when Malinda was listed as a widow. She lived in the household of her son, John H. Rozier, who the 1900 federal census claimed was born in November 1877 [16]. It is not known what became of either Malinda or John after 1900.

Esau & Caroline Rozier

Census records give a wide range of possible birth years for Esau Rozier, placing his birth sometime between 1840 and 1853 [1]. At his death in 1923, Esau's son gave 1843 as his year of birth [2]. This disparity makes it difficult to pinpoint his birth.

The discussion above described the use of "*Wright*" as the surname for the older Esau Rozier and his family on the 1870 Pulaski County federal census. It appears that our Esau Rozier was also listed by the 1870 census marshal as "*Esau Wright*," and he was also mistakenly described as a young white man. He lived in the household of Henry F. Manning, a "*Planter*," and his wife and two daughters. Esau was aged nineteen years, which would place his birth about 1851.

While Manning and his wife and daughters could all read and write, Esau was unable to read or write [3]. That alone is not enough evidence to claim that the white Esau Wright is the same as our Esau Rozier, a black man who we know could not read or write. However, in 1873, "*Esau Rozier*" was one of two freedmen employed by H. F. Manning in the Salem Militia District #348. Esau was listed on the same page as Jinny Rozier, the de facto wife of Seaborn Rozar, and their sons, William A., Ephraim, and James O. Rozier [4]. This evidence seems to indicate that our Esau Rozier was indeed the young man enumerated in 1870 as "*Esau Wright*." It also implies a Wright connection of both of the Esau Roziers.

Pulaski County tax digests exist for each year between 1874 and 1879, but Esau Rozier has not been found on any of them. This seems to indicate that he lived elsewhere during that five-year interval. By 1880, Esau Rozier had settled near Cochran in the Trippville Militia District which bordered the Salem District on its south side. That year, "*Esau Rozar*" was assessed taxes on one poll and household and kitchen furniture valued at \$10 [5].

During the 1870s, probably 1870–1872, Esau Rozier married to Caroline, who was born about 1858. In 1880, Esau and Caroline lived with their four daughters in the household of Penelope Shannon, a white woman born about 1830. The Shannon/Rozier household adjoined that of M. A. Skipper, a farmer, and Esau worked as a laborer on the Skipper farm [6]. On 18 June 1880, Esau Rozier mortgaged "*My entire Crop of Cotton & Cotton seed being six acres I cultivate on the Skipper place in Pulaski County*" to guarantee his payment of supplies valued at \$15 advanced to him by Wash Baker [7].

Esau Rozier was not assessed Pulaski County taxes in 1881, but in 1882, Esau lived in the Salem Militia District near Jinny's sons [8]. He remained there for the next fifteen years, and this proximity to Jinny's family suggests that Esau had a close connection to them. In 1884, he was

employed by Hugh Smith, but between 1885 and 1887, he had no employer. In 1886–1887, he owned livestock valued at \$40 and kitchen furniture valued at only \$5 [9].

As the Prohibition movement swept across the South, Esau Rozier registered as a “*colored voter*” in the Salem Militia District for the “*Prohibition Election*” scheduled for 18 February 1886 [10]. He was unable to pay his 1886 tax assessment, causing him to be included on the 1886 Insolvent Tax List [11].

In 1890, the last tax digest currently available for Pulaski County, Esau Rozier was assessed taxes in the Salem District along with Jinny’s sons and grandsons. He owned livestock valued at merely \$1.00, household and kitchen furniture worth \$15, and farm tools worth \$13 [12]. The next spring on 28 February 1891, Esau signed a promissory note for \$25 due October 1st to A. P. Urquhart. To secure his payment of the note, Esau mortgaged this property [13]:

One gray horse about nine years old name[d] Dock, one don [sic] colored ox about two years old named Bill; one single ox Cart.

On 3 April 1896, Esau Rozier signed a promissory note to J. B. English & Co. for \$63 due the following October 15th. To secure his payment of the note along with any other supplies furnished Rozier by J. B. English & Co. that year not to exceed \$100, he mortgaged this property:

*One Bay horse named Charlie 6 years old
One Dark Bay mule named Doc 7 years old*

Esau verified that his property was not otherwise mortgaged [14]. Between 1896 and 1900, Esau and Carolina Rozier moved their family the short distance across the county line into Laurens County.

Esau and Caroline Rozier lived in Laurens County, Georgia by 1900, and they farmed there until his death on 23 May 1923. He died near Dexter, and his physician listed his cause of death as “*Old age with complications*” [15]. In 1930, Caroline lived in Dexter and did laundry for a local family [16]. She was probably the “*Caroline Rozar*” who died in Dodge County, Georgia on 6 September 1939 [17].

Known Children of Esau & Caroline Rozier

Esau Rozier had two known wives, Malinda Williamson, to whom he married in 1867, and Caroline, to whom he married sometime in the 1870s. It is not known if Malinda died, or if they divorced, nor is the precise date of marriage of Esau and Caroline known. As a result, it is unclear whether Malinda or Caroline is the mother of Esau's elder daughters.

Their known children as documented by the 1880 and 1900 federal censuses include:

1. **Lucy Rozier** (c1873–aft. 1880).
2. **Laura Rozier** (c1876–aft. 1880).
3. **Mary Rozier** (c1878–aft. 1880).
4. **Mattie Eliza Rozier** (Jul 1879–aft. 1900).
5. **Mollie Rozier** (Sep 1882–aft. 1900)
6. **Green Rozier** (8 Feb 1885–22 Feb 1966) lived in his parents' 1900 household. He married on 8 March 1905 in Laurens County, Georgia to Virgia Neal. Green married on 13 July 1924 in Pulaski County, Georgia to Rosa Lee Powell (c1904–aft. 1950). Green Rozier died in Dodge County, Georgia.
