#### 1. Introduction

All records of Hosea Bright Breazeal and his wife Sarah Elizabeth Mayfield Breazeal known to me at this time are transcribed below, *except* for census records. I have concentrated on H. B. Breazeal's family since much less is known about his parentage than that of his wife Sarah. The records that follow were transcribed from photocopies of the originals in my possession or from microfilm of the originals. If anyone knows of additional records not included herein, please share them with me.

On most of the "official" records, Hosea Bright Breazeal's name is given as "Hosea B." or "H. B." Breazeal. However, many less formal records indicate that he was casually called "Bright Breazeal". Thus, I shall refer to him as "Bright Breazeal" in the following.

Numerous people have shared their materials with me over the years and thus have helped me to compile the Breazeal records that follow. I am quite grateful to them all. First and foremost, Mr. Gene Barron of West Monroe, La. has generously shared his knowledge of our mutual relations with me over the years, including data on the Breazeal and Mayfield families. Mrs. Lois Nix of Amarillo, Tx. has provided me with much information, and the late Mr. Chester Bullock of Magnolia, Ark. very willingly sharing his Cobb research with me. The late Mrs. Ruby Smith Barron of Spearsville, La. was always glad to talk about the Breazeals with me and she loaned me her copies of the New Hope Primitive Baptist Church minutes for an extended period of time. Finally, I am extremely grateful to my dear friend, the late Mrs. Arelia Breed of Farmerville, La., for all of her generocity and assistance, and for her interest in early Union Parish Louisiana and its settlers. She has gone to a great deal of trouble in looking up many of these Union Parish records, for which I am truly grateful.

# 2. The Spelling of 'Breazeal'

To anyone who has studied this family it is clear that the spelling of the surname is not an issue. Besides the rather imaginative different spellings of the name by others, Bright Breazeal himself spelled his surname in a variety of ways during his lifetime. He was not consistent in spelling his surname even when making entries in his own family Bible or in the church minute books while he served as church clerk. At various times in his life, Bright spelled his surname "Brazeal", "Breazeale", and "Breazeal".

The spellings "Brazeal" and "Breazeale" were most commonly used by Bright and his relatives until about 1870, often interchangably in the same record. Between 1850 and 1870, Bright appears to have used "Breazeale" when signing his name. Beginning in the 1880s, "Breazeal" was the most common spelling used by the family, and this is the spelling used throughout the twentieth century.

Bright Breazeal used all three spellings when recording the births, marriages, and deaths of his family in his Bible. Since he was fairly well-educated for his time (he served as a justice of the peace and as the clerk of various churches), it would seem there was no "correct" spelling of the name until the latter 1800s. About that time, the descendants of Joel Breazeal became fairly consistent in spelling the name "Breazeal", the spelling used ever since.

The records transcribed below will use whatever spelling given in that particular record, but when discussing this family, I will use "Breazeal".

# 3. Brief Biographies of Bright Breazeal and Sarah Mayfield Breazeal

Hosea Bright Breazeal was born 5 April 1813 in Pendleton District South Carolina. He was the son of Nancy Breazeal (1791 – 1841), who was not married when her son was born. Nancy Breazeal was the daughter of Joel Breazeal (c1755 - 1829) and Rebecca Griffin Breazeal (c1760/70 - 1845+), who had married in Chatam County North Carolina in 1779. There is no record of the identity of Bright Breazeal's father.

Little is known of Bright's early years, but he apparently lived with his grandparents in Pendleton District South Carolina. Within a few years of Bright's birth, his mother Nancy Brezeal married a

Mr. Lawless, probably either Larkin B., Hiram, or Henry Lawless. Joel's household on the 1820 census consisted of an older male and female (Joel and Rebecca), a male aged 16–26 (apparently their son Joel M. Breazeal), a female aged 10–16 (apparently their youngest daugher Lucinda), a young male child (apparently Bright Breazeal), and several slaves.

Joel Breazeal's married children began moving westward to Tennessee and Alabama a few years before 1820. His son William Breazeal and son-in-law Azariah Cobb were in Tuscaloosa County Alabama by 1823, and in about 1824 Joel sold his plantation in Pendleton District and joined his relatives in Alabama. He bought a 240 acre farm on Bear Creek in southeastern Tuscaloosa County Alabama on 24 January 1826.

Joel Breazeal died on 5 August 1829, and by Joel's instructions in his will, the plantation became the property of his youngest son Joel Marshall Breazeal. In 1830, the household of Joel M. Breazeal consisted of a male aged 20-30 (Joel M. Breazeal), a female aged 60–70 (apparently his mother Rebecca Griffin Breazeal), a male aged 15–20 (apparently Bright Breazeal), and several slaves.

Sarah Elizabeth Mayfield was born in Pendleton District South Carolina on 17 June 1819, the daughter of Archibald Mayfield and Tabitha Bennett. Archibald was a veteran of the War of 1812, and his father Samuel Mayfield was a veteran of the Revolutionary War. Sarah spent her early years near both sets of her grandparents, Samuel and Jane Mayfield and Elisha and Sarah Todd Bennett. The Breazeal, Bennett, and Mayfield families were not only close neighbors in Pendleton District South Carolina, but also connected by marriage: Joel and Rebecca's daughter Mary Ann Breazeal married Elisha and Sarah's son Stephen Bennett in 1815.

About 1824, the Mayfields moved with numerous relatives and neighbors from Pendleton District South Carolina to Tuscaloosa County Alabama. Although the Bennetts remained in South Carolina, Archibald's parents Samuel and Jane moved with their son to Alabama. Archibald Mayfield also bought a farm on Bear Creek in Tuscaloosa County, adjoining the farm of Joel Breazeal. In addition to begin neighbors, the Breazeals and Mayfields belonged to the same church, Sardis Baptist Church.

Hosea Bright Breazeal and Sarah Elizabeth Mayfield were married on 18 February 1836 in Tuscaloosa County Alabama. They apparently lived on either the Breazeal or Mayfield plantations. Archibald Mayfield died in 1833 and upon Tabitha's death in 1842, Bright Breazeal bought 40 acres of her plantation.

Between 1846 and 1849, Joel M. Breazeal began to sell his farm in Tuscaloosa County in preparation to move west to Pickens County. This probably coincided with the death of Rebecca Griffin Breazeal (she was alive in 1844 but this is the last known record of her). When Joel M. Breazeal sold the last of his father's old plantation on 26 Januaryr 1849 and moved away, Bright Breazeal also moved his family away from Bear Creek. He settled about ten miles northwest of the old Breazeal/Mayfield plantations and bought a farm there.

A few years after the death of their mother Tabitha Bennett Mayfield in 1842, most of Sarah's siblings left Alabama for Arkansas, and Bright's aunt Rosannah Breazeal Cobb and her family also left for Arkansas. Bright Breazeal's eldest daughter Tabitha married on 12 June 1856 and died the following year, on 8 October 1857 (possibly in childbirth). A month later, on 23 November 1857, Bright and Sarah sold their Tuscaloosa County farm and moved to southern Union County Arkansas/northern Union Parish Louisiana. Although Bright was listed as a resident of northern Union Parish on 17 December 1858, shortly thereafter he settled next door to his uncle and aunt, Azariah and Rosannah Breazeal Cobb near Caledonia, Union County Arkansas. Also living nearby was Sarah's brother Andrew J. Mayfield and his family (he had married the daughter of Azariah and Rosannah Breazeal Cobb). Bright bought a farm from his first cousins Joel M. and George Cobb either in 1857 or 1858.

Bright Breazeal served as a 2<sup>nd</sup> Lieutenant in the Jackson Township, Union County Arkansas Home Guard during the War Between the States. His eldest son Andrew J. Breazeal died in the service of the Confederate States Army at Fort Pillow, Tennessee, on the Mississippi River, on 25 April 1862. His other sons Reuben S. and James K. Polk Breazeal also served in the Confederate Army.

Bright and Sarah Breazeal sold their farm near Caledonia, Union County Arkansas, on 2 November 1866 and moved a few miles south to extreme northern Union Parish Louisiana. They bought a farm north of Spearsville and remained there for the rest of their lives. Bright served as a justice of the peace

in Union Parish just as he had in Tuscaloosa County Alabama. He was also active in New Hope Primitive Baptist Church from 1872 until 1887, serving as church clerk from 1880 until 1887. Sarah died in 1888, and Bright in 1891. They are buried in the Spearsville Cemetery next to their youngest daughter, Laura Agness, who died in 1912.

#### 4. Parentage of Hosea Bright Breazeal

Hosea Bright Breazeal and Sarah Elizabeth Mayfield were both born in Pendleton District South Carolina, Bright in 1813 and Sarah in 1819. But whereas several different records prove that Sarah is the daughter of Archibald and Tabitha Bennett Mayfield, there is no known record that specifically names the parents of Hosea Bright Breazeal.

The late Hugh Barron of Spearsville, Louisiana was the grandson of Bright Breazeal's daughter Martha Ruth Etta Breazeal Rockett. Martha Rockett told Hugh Barron that her father's mother was not married when he was born. In other words, Hosea Bright Breazeal was illegitimate. To this day, no record has been found to indicate the identity of Bright Breazeal's father. It is likely that no such record will ever be found.

However, several records indicate that Bright Breazeal was the son of Nancy Breazeal and grandson of Joel and Rebecca Griffin Breazeal. The most important record is the family Bible of H. B. Breazeal. Bright recorded the birth and death dates of Nancy Lawless in his Bible. Nancy is a proven daughter of Joel and Rebecca Breazeal, as Joel named her as his daughter in his will. Also recorded in the Bible is the birthdate of Laura Lawless, presumably a daughter of Nancy Breazeal Lawless. Since the only other dates recorded in the Bible are those of Bright, his wife, and his children, this strongly indicates Nancy Brazeal Lawless was the mother of Bright Breazeal.

Here are other close connections between H. B. Breazeal and the family of Joel Breazeal:

- Hosea B. Breazeal and Joel M. Breazeal were closely associated with each other in the church records of Tuscaloosa Co AL. Joel M. Breazeal was the son of Joel Breazeal and brother of Nancy Breazeal Lawless. J. M. and H. B. Breazeal were frequently mentioned together in the minutes of Liberty Baptist Church between 1840 and 1848 as delegates to district and association meetings, on committeees, etc.
- H. B. Breazeal served as the justice of the peace on one of the deeds in which J. M. Breazeal sold his plantation in 1846.
- Bright and Joel M. Breazeal lived in the same neighborhood in Tuscaloosa County Alabama, and during the 1840s, Bright owned a farm which adjoined that of Joel M. Breazeal. Moreover, as long as Joel M. continued to live on the old plantation of Joel Breazeal, Bright continued to live in the same place, apparently on his own 40 acres he bought from his mother-in-law's, Tabitha Bennett Mayfield's, estate in 1843, but perhaps on Joel M. Breazeal's farm (we don't know how long Bright continued to own the 40 acres he bought in 1843). In November 1847, Bright Breazeal stated in church conference that he would serve Liberty Baptist Church for another year as church clerk. However, shortly afterwards he must have changed his mind, for at the next conference in January 1848, Breazeal asked for letters of dismission for him and Sarah. In February and August 1848 Bright bought land about ten miles northwest of the Breazeal/Mayfield farms on Bear Creek. The following November, Joel M. Breazeal sold part of Joel Breazeal's old plantation on Bear Creek, and he sold the remainder in January 1849. He then moved his family westward to Pickens County. The fact that both Bright and Joel M. Breazeal departed from the Bear Creek location at about the same time seems too much to be a coincidence.
- H. B. Breazeal moved his family to Union Co AR in 1858 and settled next to Azariah and Rosannah Breazeal Cobb. Rosannah Breazeal Cobb was the daughter of Joel Breazeal and sister to Nancy Breazeal Lawless. Hosea bought land from Rosannah's sons in 1859 and lived next to the

Cobbs for ten years.

• Finally, notice Bright and Sarah named one of their daughters "Nancy" and another "Laura Agnes". All three of these names were 'Lawless' names. Laura Lawless's birth date is recorded in Bright's Bible and is, I think, Bright's half-sister and daughter of Nancy Breazeal Lawless. Agnes Lawless was the wife of Asahel Lawless; they lived near Bright in Tuscaloosa County and Agnes was a member at Sardis and Asa at Liberty Church. I believe it quite possible that Asa Lawless was the brother of Nancy Breazeal Lawless's husband.

#### 5. Hosea Bright Breazeal Family Bible

Mr. Gene Barron of West Monroe is currently the owner of the family pages from Bright Breazeal's Bible. It consists of four pages with two columns to each page. Each entry in the Bible is in the hand-writing of Bright Breazeal.

<sup>&</sup>lt;sup>2</sup>The Breazeal family Bible recorded in H. B. Breazeal's handwriting and a document signed by H. B. and S. E. Breazeal in 1887 give their marriage date as on February 18. Their marriage record in Tuscaloosa Co AL indicates that a marriage license was issued for them on February 10, and their close neighbor George Cobb, a justice of the peace, informed the probate judge's office that he had married the couple on **February 12**. Presumably then, either Cobb or the clerk in the probate office made an error, and they were actually married on the 18<sup>th</sup>.

### 7. Land Owned by Hosea Bright Breazeal, 1843–1893

Hosea B. and Sarah E. Mayfield Breazeal lived their married life in four locations in three states, as follows:

- (1) (1836 1848/50) They lived on either Tabitha Mayfield's plantation or on Joel Breazeal's old plantation near Liberty Baptist Church on Bear Creek in southeastern Tuscaloosa Co AL. In 1843, Bright bought 40 acres of Tabitha Mayfield's old plantation, so perhaps he and his family lived there until 1848. However, there is no record of Bright's selling this land, so we have no way of knowing how long he remained the owner of it.
- (2) (c1850 1857) They lived on a farm about due south of the city of Tuscaloosa on Sandy Creek in Tuscaloosa Co AL.
- (3) (c1858 1867) They lived on a farm near the community of Caledonia in south central Union Co AR.
- (4) (c1868 1893) They lived on a farm north of Spearsville in extreme northern Union Par LA.

The land they owned is given in the following tables. The following abbreviations for the legal descriptions of land are used below:

- "S" for "Section"

Land sold was  $NW_{\frac{1}{4}}$  of S22, T24, R7E,  $160\frac{20}{100}$  acres, and the  $E_{\frac{1}{2}}$  of  $SW_{\frac{1}{4}}$  of S22, T24, R7E,  $80\frac{10}{100}$ . Witnesses: **George Cobb**, William Breazeal. (Joel "Brezeal" made his mark to the deed).
- 24 Dec 1833 Tuscaloosa, Alabama U.S. Government Land Office, Cash Entry #10350.

  Joel M. Breazeale (also Brazeal) of Tuscaloosa Co AL buys the  $NW_{\frac{1}{4}}$  of  $NE_{\frac{1}{4}}$  S22, T24, R7E, a total of 40.05 acres, for \$50.06. He signed this record as "Joel M. Breazeale".
- 24 Dec 1833 Tuscaloosa, Alabama U.S. Government Land Office, Cash Entry #10351.

  Joel M. Breazeale (also Brazeal) of Tuscaloosa Co AL buys the  $SW_{\frac{1}{4}}$  of  $SW_{\frac{1}{4}}$  S15, T24, R7E, a total of 40.045 acres, for \$50.06. He signed this record as "Joel M. Breazeale".
- 10 Feb 1836 Tuscaloosa Co AL Marriage Book 1837–1843, pp. 101–102.

  Marriage license for **Hosea B. Brezeal** [sic] to marry **Sarah Eliza Mayfield**. They were married by **George Cobb, J.P.** on 12 Feb 1836. (This date is incorrect, according to other records. See the Bible record and the deed of Union Par LA dated 28 Jan 1887).
  - Tuscaloosa Co AL Tax List, Beat No. 4, 17<sup>th</sup> Regiment, Captain McAdory. **H. B. Brazeale** paid a tax of \$0.26\frac{1}{2}\$ on 1 white poll, 1 slave under 10 years of age, and 1 wood clock. Paying taxes in the same neighborhood were **A. J. Mayfield**, **Tibitha** [sic] **Mayfield**, **Joel M. Brazeale**, **William Brazeale**, **Izriah** [sic] **Cobb**, and **James Ward**.
- 9 Dec 1842 Tuscaloosa Co AL Probate Book 7, pp. 146–150.

  Inventory and Estate Sale of the estate of **Tabitha Mayfield**, deceased. According to the Sale Bill of the property of the estate that was returned to court on the above date, **H. B. Brazeal** purchased the following items from the estate for the indicated amounts:

Howard commissioners appointed to sell the real estate of **Tabitha Mayfield** deceased "for the purpose of making a fair and equal division among the heirs of said estate....And the Northeast quarter of the Northeast quarter of Section 27, Township 24 of Range 7 east to **H. B. Brazeal** at four  $\frac{54}{100}$  dollars per acre amounting \$181 $\frac{60}{100}$  acres [sic] he being the highest bidder for the same..."

[Note: There is no record of Bright Breazeal selling this 40 acres bought from the estate of his mother-in-law.]

# 12 Dec 1843 Tuscaloosa Co AL Deed Book T, p. 390.

Rebecca Brazeal and Joel M. Brazeal sell two Negroes to Bradley Nall: "a man Dave and his wife Vilender, Dave about 47 and Vilender 46..." for \$400. Witnesses: Asa Guin, E. B. Mayfield. Both signed their names to the record.

#### 8 Oct 1846 Tuscaloosa Co AL Deed Book V, pp. 417–419.

**Joel M. Breazeal** and his wife **Permely Breazeal** sell land to **John Hargrove** for \$100. Land sold was the  $SW_{\frac{1}{4}}$  of  $SW_{\frac{1}{4}}$  of S15,  $SE_{\frac{1}{4}}$  of S16, and 20 acres in a square in NW Corner of S22, all in T24, R7E. Witnesses: **M. Breazeal, J.P.** [sic], **William Deason**. Deed signed by "Joel M. Brazeal" and Permely "Breazeal" made her mark to the record.

"Personally appeared before me **Hosea B. Breazeal J.P.** the within named parties **Joel M. Brazeal** and **Permely Brazeal** who acknowledged that they signed, sealed and delivered the foregoing deed on the day and year therein mentioned to the aforesaid **John Hargrove** for value recd. and the said **Permely Breazeal** being by me privately examed [sic] a part [sic] from her said husband acknowledged that she signed sealed and delivered the within deed...without any fear threats or Compulsion of her said husband..."

"Personally appeared before me the undersigned a Justice of the peace...Hosea B. Breazeale J.P. an acting Justice of the peace in and for said County."

#### 23 July 1847 Tuscaloosa Co AL Orphans Court Book 4, 1846–1850, pp. 203–204.

A total of \$5881.72 is to be distributed among the heirs of **Tabitha Mayfield**, deceased. "It is further ordered and decreed by the Court that **Hozea B. Brazealle** [sic] & **Sarah Eliza**, his wife, a daughter of said decedant [sic], are entitled to the like sum of...\$663.63."

- 22 Feb 1848 Tuscaloosa Co AL Deed Book 4, pp. 425–426 and Tuscaloosa Co AL Deed Book 7, pp. 42–43.
  - J. P. Thompson and his wife Sarah Thompson sell land to H. B. Brazeale for \$350. Land sold was the  $E_{\frac{1}{2}}$  of NW $_{\frac{1}{4}}$  of S19, T22, R9W. Deed signed by J. P. and Sarah Thompson.
- 16 Aug 1848 Tuscaloosa Co AL Deed Book 4, pp. 423–424.

William Willingham and his wife Jane Willingham sell land to H. B. Brazeal for \$350. Land sold was the  $W_{\frac{1}{2}}$  of  $NW_{\frac{1}{4}}$  of S19, T22, R9W, "...Except about two acres which I have sold to Elijah Clements in the south west corner of said tract viz. all the land on the south side of little [sic] sandy [sic] creek [sic] the creek being the line between them." Deed signed by William Willingham, and Jane Willingham made her mark to the deed. William and Jane Willingham appeared in court on 22 August 1855 to swear they made the deed.

28 Nov 1848 Tuscaloosa Co AL Deed Book X, pp. 136.

Joel M. Brazeal and his wife Permelia Brazeal sell  $79\frac{86}{100}$  acres of land to Lewis Pumphrey and Permelia Pumphry for \$20. Land sold was the  $W_{\frac{1}{2}}$  of  $NE_{\frac{1}{4}}$  of S8, T24, R7E. Deed signed by Joel M. Brazeal, and Permelia Brazeal made her mark to it. The justice of the peace was H. H. Hargrove.

26 Jan 1849 Tuscaloosa Co AL Deed Book X, pp. 3–4.

Joel M. Brazile and his wife Permelia Brazile sell 340 acres of land to John Hargrove for \$500. Land sold was the  $SW_{\frac{1}{4}}$ , the  $NW_{\frac{1}{4}}$ , and the  $NW_{\frac{1}{4}}$  of  $NE_{\frac{1}{4}}$  of S22, T24, R7E, "20 acres in a square in NW Corner of  $NW_{\frac{1}{4}}$  excepted." Deed signed by Joel M. Brazile, and Permelia Brazile made her mark to the deed. Witnesses were J. H. D\_cess, H. H. Hargrove, J. P..

11 Oct 1849 Tuscaloosa Co AL Deed Book 4, pp. 422–423.

William Willingham and his wife Hannah Willingham sell 60 acres of land to H. B. Brazeal for \$110. Land sold was the  $E^{\frac{1}{2}}$  of  $NE^{\frac{1}{4}}$  of S24, T22, R10W, 60 acres "...lying east of the Marion Road making the Marion the line and also making little [sic] sandy [sic] creek [sic] the line on the south." Deed signed by William and Hannah Willingham.

25 Jan 1850 Tuscaloosa Co AL Court of Revenue & Roads Book Beginning with the Regular Term Aug 20, 1849, p. 27.

"County Court in Vacation January 25, 1850. Ordered that **Hosea B. Brazeal** be and he is hereby appointed overseer on the Bear Creek Road from the State Road to Swindles Branch in place of **L. G. Blount** Removed."

Same book, page 29: "It is ordered by the Court that an order issue to **Bright Brazeal**, **Georg Swinde** [sic], **Elijah Williangham**, **Wm. Phifer**, **Reuben Liggins**, **Wm. Willingham**, & **Jas. Phifer** to examine & Report the expediency of altering the Bear Creek Road."

22 Feb 1853 Tuscaloosa Co AL Deed Book AA, pp. 209–210.

**H. B. Brazeale** and his wife **Sarah E. Brazeale** sell 3 acres of land to **Elijah Clements** for \$10. Land sold was the a part of the  $E^{\frac{1}{2}}$  of  $NE^{\frac{1}{4}}$  of S34 [sic – should be section 24], T22, R10W, "...that parcel of Land liing [sic] west of my fence Running from the forde [sic] Creek to my Gin House containing three acres more or less..." Deed signed by **H. B. Brazeale**, and **Sarah E. Brazeale** made her mark to the deed. Witnesses: **John Phifer, J. P.** On 28 Feb 1853, **Sarah E. Brazeal** appeared and acknowledged that she signed the above deed.

1854 Tuscaloosa Co AL Deed Book 4, pp. 424–425 (no day or month given).

Richard C. Clanton sells  $1\frac{1}{2}$  acres of land to H. B. Brazeale for  $\$7\frac{1}{2}$ . Land sold was  $1\frac{1}{2}$  acres in SW corner of  $SE\frac{1}{4}$  of  $SE\frac{1}{4}$  of S13, T22, R10W, "...beginning on the Section line where the old road crosses it between Clantons and Brazeales near a Post Oak 3X From thence N5.6 E9 ch to a Stake 3x. the old road the line near a dun thence down the drian (?) to a stake 3x: on the Section line Thence along section line...to the beginning..." Witnesses: William Willingham, John H. Ward. Deed signed by Richard Clanton. On 23 Nov 1857, William Willingham swore to the deed before probate Judge Moses

McGuire. [H. B. Breazeal was referred to as B. H. Brazeale at one place in this deed.]

23 Nov 1857 Tuscaloosa Co AL Deed Book 4, pp. 426–427.

Hosea B. Brazeal and his wife Sarah E. Brazeal his wife sell land to William Willingham for \$1500. Land sold was  $E_4^1$  [sic – should be  $E_2^1$ ] of  $NW_4^1$  and  $W_2^1$  of  $NW_4^1$  of S19, T22, R9W, "...except about two acres heretofore sold to Elijah Clements in the SW Corner lying on the south side of Little Sandy Creek the Creek being the line..." Also sold was the  $E_2^1$  of  $NE_4^1$  of S24, T22, R10W, "...60 acres more or less lying E of the Warrior Road which is the line and making little Sandy Creek the line on the south a tract of land beginning..." [the exact description that Breazeal bought from Clanton in 1854, except that the word "dun" there is "drian" here.]. Deed signed by H. B. Brazeal, and Sarah E. Brazeal made her mark to it. On this same day, Probate Judge Moses McGuire says that H. B. and Sarah Brazeal "...who are known to me..."

[Note: Bright and Sarah Breazeal must have thought a lot of their neighbors William Willingham and Elijah Clements, for they named their son born in 1859 "Elijah Willingham Breazeal".

  Joel M. Cobb and Geo. Cobb, Jr. of Union Co AR buy the NW<sup>1</sup>/<sub>4</sub> of SE<sup>1</sup>/<sub>4</sub> of S22, T19S, R15W.
- 19 Aug 1857 Campagnolle, Arkansas U.S. Government Land Office, Cash Entry #7041. **Joel M. Cobb** and **Geo. Cobb, Jr.** of Union Co AR buy the  $E_{\frac{1}{2}}$  of SW $_{\frac{1}{4}}$  of S22, T19S, R15W.
  - 1857–1859 Bright Breazeal purchased the above three tracts of land from his first cousins Joel M. and George Cobb. Although there is no recorded deed of the purchase, the following record indicates Bright was the owner of this land by 20 Aug 1859.

"...I enter the same for the use of an adjoining farm owned by me, which is situated on the..."  $E_{\frac{1}{2}}$  of  $SW_{\frac{1}{4}}$  and  $W_{\frac{1}{2}}$  of  $SE_{\frac{1}{4}}$  of S22, T19S, R15W, "...upon which there are Twenty acres in cultivation, besides a dwelling house..." The document was signed **Hosea B. Breazeale**.
  - July 1861 Union Co AR County Court Record Book E, p. 634.

    July Term of Court, List of the Jackson Township Home Guard: "It is ordered by the Court that the following named persons be & they are hereby appointed as a Home Guard of Jackson Township in this County." Those listed included H. B. Brazzeal, 2 Lieutenant; S. T. Cobb, 3 Lieutenant; G. Cobb, Jr. orderly Sergant; and T. A. Groves, J. H. Pratt, A. R. Cobb, J. P. Sumners.
  - 2 Nov 1866 **H. B. Brazzeal** and his wife **Sarah E. Brazzeal** sell 200 acres of land to **George H. Thompson** for \$1000. Land sold was the  $E_2^1$  of  $SW_4^1$ , the  $W_2^1$  of  $SE_4^1$ , and the  $SE_4^1$  of  $SE_4^1$  of  $SE_4^1$  of  $SE_4^2$  of  $SE_4^2$

#### 10. Records of Union Parish Louisiana

Hosea Bright Breazeal left numerous records in Union Parish Louisiana, including land transactions, tax records, civil suits, homestead exemption, a stock mark, oath of office a justice of the peace, plus a large number of legal records relating to the estate of James Jeter.

#### 10.1. Land Records.

- 1 July 1870 New Orleans, Louisiana U.S. Government Land Office Homestead Application #1556, District of Monroe. Application was for 40.28 acres, date of entry was 1 July 1870, date of residence was 10 July 1870, the proof and certificate were dated 2 Feb 1876. "Improvements: houce [sic], 7 acres cleared & fenced, 7 acres broken, 7 acres in crop, 5 seasons of planting. Residence claimed: 5 years, 7 months, 1 day." On 1 July 1870, **H. B. Brazzeal** pays \$7 to enter the SE\frac{1}{4} of SE\frac{1}{4} of S26, T23N, R3W, signed **H. B. Brazzeal**. His affidavit, dated 17 July 1870 and signed as **H. B. Brazzeal** stated:
  - "I, **H. B. Brazzile**, of Union Parish La...do solemnly swear, that I am a citizen of the U.S. & the head of a family that I make this entry for the purpose of actual settlement & cultivation that said application No. 1556 is made for my own use & benefit & not for the use or benefit of any other person or persons whatsoever & that I have never heretofore had the benefit of this act. I make this affidavit before a clerk of court on account of Distance & expense of proceeding to the land office at New Orleans La being too great for me to attend there in person."

The clerk's statement: "...J. W. Reid Clerk District Court Union Parish La and I do certify that H. B. Brazzil is a resident citizen of Union Parish La."

The Final Certificate #57 was dated 2 Feb 1876, Monroe, and the amount paid was \$1.00. The following affidavit dated 2 Feb 1876, under the Homestead Act of 20 May 1862, was signed by **H. B. Brazeal** and stated:

"...do solemnly swear that I am a citizen of the United States; that I have made actual settlement upon and have cultivated said land, having resided thereon since the  $10^{\text{th}}$  day of July, 1871 [sic]..." (at other places the date of settlement was given as 10 July 1870).

The proof for the homestead application was given by **E. J. Pouncey Sr.** and **A. C. Peppers**, who stated they have known **H. B. Brazeal** for 6 years past, that he settled on the land on 10 July 1870, has built a house, and he had "...cleared and fenced about 7 acres of said land."

- 8 Nov 1873 Union Par LA Deed Book V, pp. 639–640.
  - Thomas B. Killgore of Texas sells 150 acres of land to H. B. Brazzeal of Union Par LA for \$300. Land sold was the  $NE_{\frac{1}{4}}$  of S26, T23, R3W, except for 1 acre where J. D. Barron's horse lot is, and 9 acres in the NW corner of the quarter section. Witnesses: J. R. Goyne, T. J. Tabor.
- 13 Mar 1880 Union Par LA Deed Book 1, pp. 46–47.
  - **H. B. Brazzel** sells 111 acres of land to **H. W. Brazzel** for \$150. Land sold was the  $SE_{\frac{1}{4}}$  of  $SE_{\frac{1}{4}}$  of S24 and the  $W_{\frac{1}{2}}$  of  $NE_{\frac{1}{4}}$  of S25, T23 R3W, less 9 acres of the south end of the second tract deeded to **Wm. Post**. Witnesses: **W. A. McDaniel**, **S. T. Poe**.
- 16 Jan 1884 Union Par LA Mortgage Book G, p. 212.

The homestead exemption of **H. B. Breazeal**. The following was sworn to before **W. W. Heard**, a deputy Clerk of the District Court of Union Par LA, and it was signed as **Hosea B. Brazeal**:

"Personally came and appeared before me the undersigned lawful authority **Hosea B. Brazeal** who after being sworn declares that he is the head of a family consisting of his wife and a grandson dependant [sic] upon whom for a support. That he resides up on and ownes [sic] by title or act of sale from **T. B. Killgore** the following tract of land to wit: the North East quarter of section Twenty six except one acre where **J. D. Barron** [sic] horse lot is, and nine acres in the North East corner of said quarter section..." T23N R3W, 150 acres, and that this land "...together with the improvements is worth not less than Four

Hundred Dollars. That he has one brown mule worth about eighty dollars. That he has about six head of hogs worth about Twenty dollars, One wagon worth about fifty dollars, Eight head of sheep worth Eight dollars. That he is a farmer and has about one hundred fifty bushels of corn and one thousand pounds of fodder necessary for his farming work. Also about five hundred pounds of pork. That the corn, fodder & pork are worth about one hundred fifteen dollars. That it is his intention to claim the homestead exemptions upon the hereinbefore [sic] enumerated property all of which he is the bonafide owner and possessor."

# 28 Jan 1887 Union Par LA Deed Book W, p. 1.

"Be it remembered that before me William W. Heard Deputy Clerk and Notary in and for the Parish of Union... personally came and appeared Mrs. Sarah E. Brazeal and her husband Hosea B. Brazeal both residents of Union Parish La. and the said Hosea B. Brazeal husband acknowledges and declares before me that he and his said wife Mrs. Sarah E. Brazeal were lawfully married in Tuscaloosa County Alabama on the  $18^{th}$  day of February 1836 and about Six years after said marriage his said wife received from her mothers, Mrs. Tabitha Mayfields Succession in land and money the sum of Five Hundred dollars, this Money and land was [sic] her own separate paraphernal [sic] property, and when they moved to this State in 1858 he took charge of her said money and funds and disposed of them for his own use and benefit, and he is now due his said wife the said sum of five hundred dollars for her own separate paraphernal funds and now in order to restore the same to her and in part pay her the amount he is due her hereby bargains, sells, gives in payment and delivers unto his said wife the following discribed [sic] land situated in Union Parish La..."  $NE_{\frac{1}{4}}$  of S26, T23, R3W less 10 acres for a total of 150 acres valued at \$400. "...he also bargains, sells, transfers, gives in payment and delivers to his said wife the following personal property to wit:"

"And the said **Sarah E. Brazzil** being present and authorized by her husband hereby accepts all of said property at the prices stated and... hereby resumes the administration of her paraphernal property." Witnesses: **Jas. A. Ramsey**, **Geo. Fenton**. Signed by **H. B. Brazeal** and **Sarah E. Brazeal** made her mark to the record.

[Note: "Restitutions" such as the above were commonly made in the mid-to-late 1800s in Louisiana during situations where the husband was in the process of being sued and was likely to loose his property; placing property in the wife's name prevented it from being seized and sold to recover the damages from the suit. Bright Breazeal was sued by some of the grandchildren of James Jeter for his actions as administrator of Jeter's estate. He lost the suit and had to pay a relatively small sum in damages. Perhaps in fear of future judgements against him in this matter, he made this restitution. By legally placing his property in Sarah's name, it would not be possible for the court to seize any of his property to pay for any future judgements against him. It is an ironic example of that era that while Bright donated his property to his wife as her separate property, as her husband he had to give his permission for her to accept this donation!]

30 Jan 1893 Union Par LA Deed Book 2, pp. 126–127.

"I H. W. Brazzile... do by virtue of the special written power of attorney to me given by the heirs of H. B. and Sarah E. Brazzeal Deceased..." sells 40 acres to B. Frank Post for \$10. Land sold was the  $SE_{\frac{1}{4}}$  of  $SE_{\frac{1}{4}}$  S26, T23, R3W. Witnesses: W. M. Post, Jr., R. B. Stokes. The deed was signed by H. W. Brazzeal, Agt. and B. Frank Post.

17 Dec 1858 Union Par LA Civil Suit #1207, **H. B. Breazeale** vs. **Wm. Jones**. Breazeal's attorney **D. Puckett** made the following petition to the Judge of the 12<sup>th</sup> District Court, Union Parish Louisiana:

"The petition of Hosea B. Breazeale a resident of the aforesaid parish and state respectfully shows that on or about the twenty sixth (26) day of November one thousand eight hundred & fifty eight (1858) he tracted for a certain gray Gelding of William Jones, also a resident of said parish of Union, for which gray horse or gelding your petitioner gave the said **Jones** a fine young mare worth one hundred and twenty five dollars and his certain promisary note for thirty dollars drawn in favor of said Jones or bearer and due on the first day of March 1859. Petitioner avers that said **Jones** represented the aforesaid horse or gelding as sound property and free from all recthibitory [sic] vices. Petitioner further avers that said horse or gelding was unsound at the time of the trade, and so diseased as to render him entirely worthless. Petitioner further avers that he has made a tender of said horse or gelding to the said **Jones** and demanded his mare and note, that said **Jones** refuses to give petitioner any satisfaction alleging that he has disposed of the mare and defies the law. Petitioner further represents that he is damaged in the sum of twenty five dollars for being kept out of the use of his said mare and being compelled to keep and feed a worthless animal. Wherefore petitioner prays that the aforesaid **Jones** be duly cited to answer hereto and on final hearing of the case he be decreed to pay your petitioner the following sums, to wit; one hundred and twenty five dollars being the value of the aforesaid mare, thirty dollars it being the amount of said promisary note, and twenty five dollars damages for costs of suit and for general relief, etc."

"I H. B. Brazel do solemnly swear or affirm that I accept the civil and political equality of all men and agree not to attempt to deprive any person or persons on account of race color or previous condition of any political or civil right privelege [sic] or immunity enjoyed by any other class of men. That I will support the Constitution and laws of the United States and the Constitution and laws of this state and that I will faithfully and impartially discharge and perform all the duties incumbent on me as Justice of the Peace for the Seventh Ward of the Parish of Union according to the best of my ability and understanding so help me God."

The document was signed H. B. Breazel and by W. W. Heard, Clerk of the District Court.

3 Sept 1882 Union Par LA Marriage Book 6, p. 405.

Marriage record of Hosea H. Rockett to Mrs. Martha R. Groves. They were married by William Hunt, M.G. and the witnesses were H. B. Breazeal, R. W. Goyne, and J. B. Hayes.

23 July 1883 Union Par LA Marks & Brands, Book A, p. 83.

H. Bright Brazeal's Stock Mark:

"Clerk's Office. Before me, the undersigned legal authority, personally came and appeared **H. Bright Brazeal**, to me personally well known who declares and says that he claims the following to be his stock mark to wit: A crop off of each ear, and an under-bit in the right ear, and makes this his declaration & application to have the same recorded.

Breazeal signed this document before Jas. M. Smith, the Clerk of the District Court.

10.3. The James Jeter Succession. Bright Breazeal became connected to James J. Jeter in 1859, when his daughter Arrena Emaline Breazeal married Jeter's son James Charles Jeter. According to information provided by Mrs. Lois K. Nix, a descendant of James Jeter, he was born about 1795 in Edgefield District South Carolina. Jeter married Nancy L. Caswell (c1804 – 1864) in Putnam County Georgia on 27 Dec 1819. Jeter served in the War of 1812 under General Andrew Jackson and also participated in the Battle of New Orleans. He moved from Macon County Alabama to Union County Arkansas between 1840 and 1850, and then between 1850 and 1860 settled in northern Union Parish Louisiana. He left Louisiana for Texas in 1864, and he died in Hopkins County Texas in 1870.

When James J. Jeter died in 1870, he was still the owner of 440 acres of land in northern Union Parish, plus a small amount of other property left on his old farm. In 1870 Bright Breazeal applied to be appointed the administrator of the estate of James Jeter. It is not known what motivated Breazeal to make this decision, as Jeter did not owe Breazeal any money. Perhaps he was requested to handle the matter by his son-in-law James C. Jeter, son of the deceased James J. Jeter.

Whatever the reasons behind Breazeal's deciding to act as Jeter's administrator, it was a move that would haunt him for at least the next seventeen years, as it entangled him in a complicated legal matter involving Jeter's grandsons William P. and John W. Reppond. James J. Jeter's daughter Lucresia Jane Jeter (1836 – 1866) married Ettienne Andrew Reppond in Union County Arkansas on 29 Dec 1853. Their sons William P. and John W. Reppond began legal proceedings against Hosea Bright Breazeal in 1883 in connection with Breazeal's actions as administrator. Keep in mind that the Repponds pursued these legal matters against the father of their aunt, Arrena Emaline Breazeal Jeter, wife of their mother's brother James Charles Jeter.

The material which follows comes from three sources, James Jeter's succession and two civil suits filed by Jeter's grandsons against Bright Breazeal.

7 Feb 1870 Union Par LA Succession Book 2, p. 623. Petition for Administrator and Inventory.

"To the Honorable the Judge of the Parish Court in & for the Parish of Union State of Louisiana, The petition of **H. B. Brazeale** a resident of the Parish and State above written with respect represents that **James Jeter** late of same residence departed this life during the year 1866 intestate leaving a small estate consisting of Land, rights and credits. Petitioner avers that an Administration of said Estate is necessary. Wherefore he prays that an order may issue from your Honorable Court directing and authorizing **Wm. C. Smith** Parish recorder & Ex-officio Notary Public in & for Union Parish La. to make an inventory and appraisement of all the property belonging to the said Estate Estate [sic] of **James Jeter** dec'd. and after all legal delays that he may be appointed and confirmed as Adm. of same for all further orders & decrees necessary in the premises & for general relief, etc.

Mayo & Lewis Attys for Petr."

Parish Judge **T. B. Tompkins** ordered and decreed that **H. B. Brazile** be appointed administrator of the Estate of **Jas. Jeter** Dec'd.

11 Mar 1870 Union Par LA Succession Book 2, p. 624–625. Appraisers and Inventory.

Appraisers of the property of the estate of **James Jeter** were appointed: **G. A. Bruton** and **W. D. M. Bruton**. Inventory of **James Jeter's** estate listed the only property as 440 acres of land valued at \$550.

12 Mar 1870 Union Par LA Succession Book 2, p. 624. Oath of Administrator.

"I **H. B. Brazile** do solemnly swear that I will faithfully and impartially discharge all the duties incumbent upon me as Administrator of the Estate of **James Jeter** Deceased, according to the best of my ability and understanding So help me God..."

25 Apr 1870 Union Par LA Civil Suit #127-E, H. B. Brazeal, Admr. Jas. Jeters Est. vs. Thos. Wheeler.

"State of Louisiana, Parish of Union, Parish Court. Personally appeared before me the undersigned lawful authority **Hosea B. Brazeal** Admr. of the Estate of **James Jeter** decd. and Pltff. in the above entitled cause [case] who after being by me duly sworn deposes that **Isaac Reppond**, **Benjm. Day**, and **James M. Turner** are competent and important witnesses in his behalf in the prosecution of the said suit and that the personal attendance of said witnesses in open court on the trial of said case is necessary in order to elicit the truth from such witnesses which cannot be done by taking their deposition out of Court. Sworn to & subscribed before me this  $25\frac{\text{th}}{\text{April 1870}}$ .

[Note: The above record is all that remains in the file for Civil Suit #127-E. Many papers are loose and unsorted, so the remainder may be located in the future.]

23 July 1883 Union Par LA Succession Book 2, p. 626–627. Proceedings of Sale of Real and Personal Property.

"I H. B. Brazel Administrator of the Estate of James Jeter Dec'd. having Advertised to sell for cash all the real Estate belonging to said Succession and after offering the same at public outcry at Marion La. on \_? day of \_? A.D. 1871 and there being no bidders for the same I then proceeded to Advertise all the real Estate for sale on terms on credit in Accordance with the provises of Articles 990 & 991 of the Code of practice said sale being Advertised for more than fifteen days in a public Newspaper published at Farmerville La. called the Union Record to be had at the door of the Court house at Farmerville on the 26 day of December A.D. 1871 and the sale in pursuance of the orders of the Honorable the Parish Court of Union Parish to be made by the Sheriff of Union Parish as Auctioneer And upon the day & date above written I caused him to offer in forty acre lots the following described land...." The highest bidder for all 440 acres was James M. Turner, who also purchased this personal property of the estate: one corn mill for \$10, one old gin stand for \$15, and one belt for \$0.60.

[Note: Although the sale took place in December 1871, the results of the sale were not filed for twelve years. Bright Breazeal said he thought it had been filed by his attorneys, Mayo & Lewis (see below).]

16 Oct 1883 Union Par LA Succession Book 2, p. 627–628. Application and Order to Sell Property.

"The petition of **H. B. That to close said Estate & meet debts due on order of sale to sell for cash the above land is necessary. Wherefore he prays for an order to sell the said land after legal advertisement & for such other orders as are necessary.

Reppond who is an emancipated minor but who is herein aided and assisted by his curator ad litim Gill D. Russel who accepts said appointment and appears herein for the purpose of aiding and assisting said emancipated minor in this suit and proceedings, all residents of Union Parish La. respectfully represent unto your Hon. Court that petioners [sic] except said curator ad litim are the children and sole heirs of Mrs. Jane Reppond who is now deceased and who was a daughter and heir of James Jeter deceased whose succession was opened in your said parish of Union in Feb 1870 by the appointment of H. B. Brazzil of Union Parish La as administrator of said succession of James Jeter Decd. That the said H. B. Brazzil has been pretending to administer said succession for more than ten years without ever filling [sic] any account of his administration, that at the time of his appointment petitioners were both minors that there were no debts due by the estate and really no administration was necessary, but the said H. B. Brazzil has sold the [sic] most of the property several years ago and still holds the proceeds and has never settled the estate. Petitioner[s] have an interest in said succession as heirs representing their deceased mother as aforesaid.

"Petitioners aver that there is still the following described land belonging to said succession to wit the  $SW_{4}^{1}$  of the  $SW_{4}^{1}$  of Sec. 31 T22 North R3 East and the said **H. B. Brazzil** has advertised the same for sale that it is worth Sixty dollars that there are no debts owe [sic] by the estate and no necessity for said sale. That the order for said sale is illegal because granted by the clerk without a statement of the debts. That... the said **Brazzil** adms. withholds the funds already in his hand and petitioners fear that the object of this sale is to appropriate the proceeds to his own use. Petitioners aver that the admr. bond is not among the papers and that if said land is sold it will be greatly to their injury and that the said **H. B. Brazzil** will sell the same on the  $17^{\text{th}}$  of Nov 1883 [this is an error; 17 Nov 1883 was the date the suit was filed] unless restrained by in [sic] injunction from your Hon. Court....Wherefore petitioners [request an order preventing the administrator from proceeding] any further with the sale of the land described herein and which he has advertised for sale.... and that a further order issue from your Hon Court commanding the said **H. B. Brazzil** administrator to file in your Hon Court within thirteen days from the service thereof a full fair and explicit account of his administration of said succession showing the funds on hand and all his acts and doing as administrator of said succession.

Turner the purchaser. That at his request & to protect his title, Your petitioner advertised said land intended to sell it in order that a full account of his administration could be had & the property, which is all that remained, & of but little value, could be properly accounted for. He avers that he has been damaged by the illegal act of petitioners in the sum of Twenty five dollars attorney fees & that an additional cost of not less than Ten dollars has been imposed upon the estate by their illegal act. Wherefore he prays that pltffs demand be rejected and that the injunction issued be disolved and that your petitioner in his representative capacity have judgement against pltff & their security on their bond in ? in the Sum of Twenty five dollars attys fees & Ten dollars damages for illegal & unwarranted costs incurred by the acts of plantiffs & all costs.

[Note: What follows is a transcript of the trial at which H. B. Breazeal testified and defended himself against the claims of the Repponds. This is transcribed exactly as it was entered in the record books at the Union Parish courthouse. However, notice that often the questions asked and the answers given by Breazeal do not exactly "match up". It appears as if the questions and answers might have been mixed up before they were recorded in the Succession Book.]

#### "H. B. Brazzeal sworn for Admr. says:

'I am the administrator of this Estate & was appointed as such admr. in 1870.'

"Question: 'At whose request did you apply for & obtain the appointment of Admr. of this Estate?' Objected to by opponents counsel for the reason that the question is totally irrelevant & any statements from others would be hearsay evidence unless it was given in the form of a testiment [sic] required by law. Which objection is sustained by the Court for the reason that none but the declaration of the ancester (?) under whom opponents claim can be admitted in evidence to bind them. To which ruling Admr. excepts & asks his exception be noted which is done.

[Answer by Breazeal:] 'At the time I was appointed admr. Mrs. Oscar Reppond was living with her husband down on their place toward the River near the old Jeter Place. Oscar Reppond's wife was the daughter of old man James Jeter Dec'd.'

"Question: What agency did Oscar Reppond have in procuring you as admr.? Objected to by opponents counsel for the reason that it elicits the opinion of the witness that the opponents are in no manner bound by anything that Oscar Reppond did or said & his declarations to the Admr. are purely heresay. Which objections [sic] is sustained for the reason stated in the objection. To which ruling Admr. excepts & asks his exception be noted which is done.

[Answer by Breazeal:] 'I think James Jeter left 10 or 11 heirs at his death. I am certain there were ten heirs of the first set of children by his first wife. There were six girls of the first set & 4 of the girls were married. When James Jeter left to go [to] Texas 2 of those girls were unmarried & one of the boys not married. Three of the boys of the first set were married. Can't say how many of these ten are living or have children living. One of them is living in Mississippi two of them married Repponds & have children living. One of them married Hunter & has children living. I don't know how many of the boys are living two of the boys were living in Texas but don't know whether they all are living now or not. One boy is living in Arkansas. I don't know whether the two girls that went to Texas unmarried are now living or have children living. I believe all of the ten children of the first set were living at the

time I administered on this estate. **Dr. D. M. Bruton** presented me with a claim against the Estate for \$65.00 & I paid it. I paid this **Bruton** claim not long after the sale I think it was in 1870. The claim of **W. C. Smith** Recorder for \$5.50 is true & correct & I paid it. The claim of **J. W. Reid** Clerk of Court for \$10.00 is true & correct & I paid it. The claim of **Mayo** & **Lewis** Attys for \$30.00 is true & correct & I paid it & the claim of **Mayo** & **Lewis** Attys for \$20.00 is true & correct & I paid it. The claim of the Union Record for advertising for \$50.57 is true & correct & I paid it. The claim of **Zack Booth** Auctioneer for \$2.50 is true & correct & I paid it.'

The Admr. offered in evidence the claim dated Oct 17/1883, due "Gazette" for \$7.00 for advertising which was objected to by opponents counsel for the reason that it is admitted to be a claim for advertising a sale decreed to be illegal by the Court which claim the administrator has been condemned to pay personally. Which objection is sustained for the reasons stated in the objection. To which ruling admr excepts & asks his exception be noted which is done.

[Continuation of Breazeal's Testamony:] 'The claim of \$3.00 due the Gazette for publishing final acct. of this Estate is true and correct & I have agreed to pay it. The claim of \$25.00 of **J. E. Trimble** Attys fees is true & correct & I have agreed to pay it.'

"Cross Examination by opponents says: 'The **Dr. Bruton** claim is for building a screw running gear of a gin'.

[Answer by Breazeal:] 'I don't know of my own knowledge that he did the work. Dr. Bruton presented his claim to me & I paid it. I think it was before the sale of the land Dr. Bruton first presented his said claim to me. I don't recollect the date of Dr. Bruton's acct. & can't say when he did the work. I don't know whether he did the work at all or not. I don't know what was done on the place before I took [over as administrator]...cultivated before I took charge of it. I don't know whether the Gin house & screw were used after Jeter was gone. I don't know what time Dr. Bruton claimed to have done that work. I don't recollect now that I knew anything about this Bruton claim when I applied to administer. I don't know what has become of the bond in this Estate. I gave about – I don't know why that bond has never been recorded.'

"Question: 'Who went [sic] your security on that administrator's bond?' Objected to by admr. for the reason it is not pertinent to any issue in this case & the bond still as the best evidence. The Court sustains the objection on the ground the question has not [sic] relavancy [sic] to any issue in this case & not on the second ground of objection. To which ruling opponent excepts & asks his exception be noted which is done.

[Answer by Breazeal:] 'I don't know when James Jeter moved on the place he lived on when he left here. He left here about the close of the war. I don't recollect positively at what time he left. I think he moved his family when he left. He went to Texas. He never returned to this Parish that I know of before he died. He left some land here when he moved to Texas. He also left a gin stand & mill & gin band.'

"Question: 'Did not Mr. James Jeter Decd. carry all of his stock & other personal property with him to Texas except what is accounted for by the Admr.?' Objected to by the admr. for the reason that it is wholly irrelevant to any issue in the case. Which objection is sustained by the court for the reasons stated in the objection. To which ruling opponents except & ask this exception be noted which is done.

[Answer by Breazeal:] 'I have already paid Judge Trimble \$15.00. I think in this succession I paid him some since the 40 acres of land was advertised for [sale]. The \$15.00 I paid Trimble was for defending me in the injunction suit of W. P. Reppond et al vs. H. B. Brazzil Admr. I have not paid him any other money besides the \$15.00 that I recollect of.'

"Cross Examination by Admr. says: [Breazeal's Testamony:] 'Dr. Bruton presented his \$60.00 claim to me & I paid it.'

"Question: 'To whom did you submit the **Bruton** account before you paid it?' Objected to by opponents for the reason that it is irrelevant & the fact he submitted it to any one would

not bind us unless it was shown it was submitted to one through whom we inherited. Which objection is overrulled & the evidence admitted on the ground of good faith.

[Answer by Breazeal:] 'I submitted this claim of Bruton's to my Attys Mayo & Lewis before I paid it.'

"Question: 'Who had charge & control of this place & rented it before you took charge as Admr. & before the death of James Jeter?' Objected to by opponents counsel for the reason that it is totally irrelevant to any issue in the case as there is no charge against the Admr. for any rent or other charges except what is in the final acct. & Inventory. Which objection is sustained by the court for the reason stated in the objection. To which ruling admr. excepts & asks his exception be noted which is done.

"C. H. Turner Sworn for Adms. says: 'I am a son of James M. Turner. I know what they call the 400 acres tract of land belonging to the Estate of James Jeter Decd. Evidence of Admr. Closed

Nov. 13, 1885

S. H. Spigner sworn for Opponents says: 'I am acquainted with W. P. & Jno. W. Reppond opponents herein.... I think James Jeter left here in 1864 to go to Texas. It was my understanding he left a tract or parcel of land when he left here. I suppose he took his family to Texas when he left. It is my understanding he James Jeter was living in some part of Texas when he died. I helped to build a....cotton press on James Jeters place myself. This was several years before Jeter left the State. I don't know of any screw being built on that place after Jeter left it. I don't know of Dr. Bruton having done any work on the gin or screw either. I have been acquainted with the Jeter Place for at least 30 years. I never heard of any new screw being put up on that place by Dr. Bruton or any one else since Jeter left there.'

"Cross Examination by Admr. says: [Spigner's Testamony:] 'I don't think **Dr. Bruton** could have put a screw on that place without my knowing it. I have lived further than  $3\frac{1}{2}$  miles from the **Jeter** place in 20 years. I don't recollect, but it was sometime before the war that I helped build the Screw on that place. I don't recollect but maybe some 2 or 3 years before the war. I never was in the war but about 3 months the latter part of the war. I knew **Dr. Bruton** personally.'

"Question: 'From what you know of **Dr. Bruton** is he a man who would claim pay for work that he had never done or had done?' Objected to by opponents counsel  $1^{\underline{st}}$  becaused it elicits the opinion of the witness,  $2^{\underline{nd}}$  If the character of a man was admissable in a case of this kind it would not Justify an Admr. paying a pretended claim against the Estate,  $3^{\underline{rd}}$  The evidence sought is totally irrelevant to any issue in the case & does not bind the opponent. Which objection is sustained by the Court for the reason the evidence is irrelevant. To which ruling Admr. excepts & asks his exception be noted which is done.

"W. P. Reppond sworn for Opponents: 'My mother was named Jane Jeter. Her father was James Jeter. My mother is dead. I have been knowing the Jeter place for the last 15 years. I have not known of any improvements being built on the Jeter Place by Dr. Bruton. I remember my father coming back from the war. I lived then (about the time father came back from the war) about 8 or 9 miles from the Jeter place.'

"Cross Examination by Admr. says: [Reppond's Testamony:] 'I don't recollect how old I was when my father came back from the war. I will soon be 25 years old. I visited the Jeter place once in a while with my father before, & up to 1870. I don't recollect how often I visited it a year. I went with my father in his buggy when I went to the Jeter place. I don't remember who was living on the Jeter Place at that time. We usually went by the place & sometime we stopped in. I can't remember any specific time I was on the place from 1867 to 1870. I recollect seeing my grandfather James Jeter one time.'

"All the papers in the Estate of **Jas. Jeter** Dec'd. filed in evidence by Pltff is including petition & order for administration & inventory, Inventory Leters & oath of admr & marked.

Evidence of Opp. closed"

"Evidence in rebuttal: H. B. Brazzil recalled for Admr. says:

Question: 'When the account of **Dr. Bruton** was presented to you what proof was there if any of the correctness of the account?' Which question was objected to be [sic] opponents counsel for the reason that the evidence sought if admitted at all would be admissible only in the original opening of his case second, any proof that he might have had of the account being Ex parte also res index alias octa is not binding on the opponents & is not admissable against them. 3<sup>rd</sup> Carde testimony of the proof is not the best evidence. Which objection was sustained by the Court for reasons that the evidence sought is not the best evidence & the affidavit itself to the correctness of the act. would not be admissable of in Court & the objection is not sustained on the ground of it not being rebutal [sic] evidence to which ruling the Admr. excepts & asks that his exception be noted which is done.

Evidence closed"

10.4. Tax Records of Union Parish Louisiana. These tax records are now on microfilm at the Louisiana State Archives in Baton Rouge. Earlier this century, they were removed from the courthouses and microfilmed. In the typical wisdom of modern Louisiana government officials, the originals were then destroyed.

The tax information for Bright Breazeal for the years 1868 through 1892 is given on the following table. He was not listed on the 1867 tax list, so he must have not moved from Union County to Union Parish until late 1867 or early 1868. Also, his heirs sold his land in January 1893, and so his estate had no property to report in 1893 or subsequent years.

#### 11. AGRICULTURAL CENSUS RECORDS

The U.S. censuses from 1850 until 1880 consisted of various parts, called *schedules*. What most people refer to as "the census" was actually the population schedule. There were also agricultural, manufacturing, and mortality schedules, and in 1850 and 1860, there were slave schedules. The data from the 1850, 1860, 1870, and 1880 agricultural schedules on Bright Breazeal's farms is given below.

#### 12. Church Records

We are fortunate that the church minutes of several churches of which Bright Breazeal was a member have survived. Of all the numerous records left by Breazeal, I think these are the most interesting. Whereas censuses and court records are typically dry and give little insight into the personality of participants, church minutes are often filled with personal information. Since Bright served as the church clerk of two different churches whose minutes have survived, we have numerous samples of his handwriting and of his monthly activities in church. He was clearly dedicated to his religion, for while he was serving as church clerk, he never once was absent from the monthly conferences held on Saturday.

Bright Breazeal was a Baptist, and in his later years, he belonged to the Primitive Baptist faith. The church minutes of at least three churches to which Bright belonged are extant: Sardis Baptist Church and Liberty Baptist Church in Tuscaloosa County Alabama, and New Hope Primitive Baptist Church in Spearsville, Union Parish Louisiana.

Bright Breazeal was elected as clerk of Liberty Baptist Church in June 1846 and served until January 1848. Many years later, in early 1880, he began serving as the church clerk of New Hope Primitive Baptist Church and served until November 1887. It is quite interesting to study the differences in Bright's handwriting in the 1840s and in the 1880s. His spelling was quaint in both time periods, and changed very little. However, as a 30-year old church clerk in the 1840s, he clearly had more patience in recording the minutes than he did as an 70-year old man in the 1880s. And as one would expect, his writing in the 1840s was clearer and more precise than it was later in his life.

Every entry from the various church minutes involving Bright Breazeal and his relatives is transcribed below. All original punctuation has been retained, and errors in the original are always followed by the standard "[sic]". It is often difficult to determine if certain words are capitalized or not, especially words beginning with the letter "C". In addition, when referring to a church member, certain clerks used "brother" or "br." before the member's name without capitalizing it. As this was done so often, I have not followed each instance by the usual "[sic]". Rather, I have transcribed them as they were originally written.

12.1. Sardis Baptist Church Minutes, Tuscaloosa County Alabama. These minutes are on file in the Special Collections Department of Samford University Library in Birmingham, Alabama. Unless otherwise noted, every entry took place on the Saturday before the first Sunday of each month, which is when the church conference was held, with services held on both Saturday and Sunday. Sundays were always called with the "Lord's Day" or the "Sabbath".

Sarah Elizabeth Mayfield joined Sardis Church by experience in September 1832, along with her eldest brother Andrew J. Mayfield and a sister, Arrena M. Mayfield. They, along with their mother and grandfather, Tabitha and Samuel Mayfield and Rebecca Griffin Breazeal, were dismissed from Sardis in November 1835 to constitute an "arm" of Sardis that became Liberty Baptist Church.

Bright Breazeal joined Sardis Baptist Church by experience a few months after Sarah, in November 1832. He was excluded from Sardis Church in June 1835, apparently in relation to his handling a matter involving Samuel Mayfield, his future grandfather-in-law. He was restored to membership a few years later, in November 1837, and then he was dismissed from membership at Sardis by letter on the first Saturday of August 1838. At the next meeting of Liberty Church on the third Saturday of that same month, he requested to join Liberty.

Here is a list of the people mentioned in the Sardis Church minutes that are connected to Bright Breazeal:

Elder Joab Pratt: He was the minister at Sardis for many years, and he later often preached at nearby Liberty Church. In the midst of the Panic of 1837, he led a large group of Tuscaloosa County residents west to Arkansas, settling in what was then Saline County, now Grant County. The town of Prattsville in present-day Grant County was founded by these settlers and named after Elder Pratt. In the early 1840s, other groups of Tuscaloosa County residents left Alabama to join Pratt in Arkansas, including Sarah Elizabeth Mayfield Breazeal's eldest brother Andrew J. Mayfield, who had married Azariah and Roseannah Breazeal Cobb's daughter Rachel Breazeal Cobb in 1841. In about 1844, Sarah's youngest three siblings Tabitha Ann, Talitha Cumi, and Archibald Pinkney Mayfield all joined their brother in

Arkansas, as well as Bright's aunt and uncle, Rosannah Breazeal Cobb and Azariah Cobb. In the mid-1850s, Elder Pratt and many of these settlers moved south from Grant County to southern Union County Arkansas, including Rosannah and Azariah Cobb. Pratt is said to have preached the very first serman in the new Union County Arkansas county seat of El Dorado in 1846.

Nancy Breazeal Lawless: Bright's mother petitioned to be dismissed from Sardis in October 1827 (called "Lollis" in the minutes), but there is no record of her joining the church. Other researchers have indicated that the early church clerks were rather sloppy in recording membership. She rejoined at Sardis in November 1831 and remained a member until her death in 1841.

**Joel Breazeal:** Bright's grandfather; he joined Sardis in February and died on August 5, 1829.

Rebecca Griffin Breazeal: Bright's grandmother; there is no record of her joining the church, but she was dismissed from Sardis in November 1835 with many others to form an "arm" of Sardis that later became Liberty Baptist Church.

**Agnes Lawless:** Her relationship to Nancy Lawless is unknown, but her husband Asahel (Asa) Lawless was possibly a brother to Nancy's husband.

Rachel Lawless: Her relationship to Nancy Breazeal Lawless is not known. She could have been Nancy's daughter and so a half-sister of Bright Breazeal, but there is no proof of this. There were at least three Lawless households in that area and very little is known about any of them.

Azariah Cobb: Bright's uncle, the husband of Rosannah Breazeal Cobb. Rosannah was the daughter of Joel and Rebecca Griffin Breazeal. Azariah was in Tuscaloosa County by 1823, and he left there in 1841 or 1842 and moved to Saline County Arkansas with Elder Joab Pratt and other Tuscaloosa County residents.

Tabitha Bennett Mayfield: Mother of Sarah Elizabeth Mayfield Breazeal.

Samuel Mayfield: Grandfather of Sarah Elizabeth Mayfield Breazeal. Samuel Mayfield was regularly cited for drunkness in the Sardis minutes. In February 1835, Bright Breazeal was appointed to cite Samuel Mayfield to attend the next conference to answer charges of drunkness and "swapping horses". Perhaps due to Bright's relationship with the Mayfields, he must not have handled this matter to the satisfaction of the church. Bright was excluded from Sardis Church in June 1835 "for making fals [sic] statements in the Church…"

Andrew J. Mayfield: Born 1815, eldest brother of Sarah Elizabeth Mayfield Breazeal. He married Rachel Breazeal Cobb, the daughter of Azariah and Rosannah Breazeal Cobb in 1841. They left Tuscaloosa County in 1841 or 1842 along with many other of their relatives and presumably first settled in Saline County Arkansas. But in the late 1840s, they moved south to Claiborne Parish Louisiana. Finally, in the 1850s, they moved a short distance north to southern Union County Arkansas and settled near Rachel's parents.

Arena Amanda Mayfield: Born 1817, elder sister of Sarah Elizabeth Mayfield Breazeal. She married John H. Pitman on 11 Oct 1832, and they moved to Mississippi in the 1840s.

Rachel B. Cobb: Bright's first cousin; a daughter of Azariah and Rosannah Breazeal Cobb. She later married Andrew J. Mayfield, elder brother of Sarah Elizabeth Mayfield Breazeal.

Sarah C. Cobb: Bright's first cousin; a daughter of Azariah and Rosannah Breazeal Cobb.

Other Cobbs: The precise relationship of the following Cobbs who were members of Sardis Church to Bright Breazeal is unknown. They are possibly nephews or neices to Bright's uncle Azariah Cobb: John S. Cobb, Samuel T. Cobb, Hugh B. Cobb, George H. Cobb, Sarah Ann Cobb.

Larkin Lawless: Relationship to Nancy Breazeal Lawless is unknown. He is one of the three adult male Lawlesses in the Bear Creek area. Judging the ages on the 1830 and 1840 censuses, he does not appear to be the husband of Nancy Lawless.

Jonathan Lawless: Relationship to Nancy Breazeal Lawless is unknown.

James Lawless: Relationship to Nancy Breazeal Lawless is unknown.

Pratt** Complained against **Br. Haggard** for Talking hard about him and not taking a gosple step the Case was taken up and laid over..."
- Sept 1838 Page 69. Rosanah Cobb was received by experience.
  - 1841 Page 81. "...Sister Nancy Lawlis [sic] Departed this life June the 17 1841."
  - 12.2. Liberty Baptist Church Minutes, Tuscaloosa County Alabama. These minutes are on file in the Special Collections Department of Samford University Library in Birmingham, Alabama. Unless otherwise noted, the conferences were held on the Saturday before the third Sunday of each month. Services were usually help on both Saturday and Sunday. Sundays were often called the "Lord's Day" or the "Sabbath".

Both Bright and Joel M. Breazeal were rather active in the affairs of Liberty Church, serving on numerous committees, as delegates to both district and associational meetings, etc. Bright Breazeal appeared to keep a rather low profile for the first few years he was a member at Liberty, whereas Joel M. was frequently mentioned beginning a few months after he joined in October 1837. Until about February 1842, any mention of "Brother Breazeal" appears to have referred to Joel M. Breazeal. After that, their first names are nearly always given to distinguish them.

In June 1846, Bright Breazeal was chosen clerk of the church for one year, and in November 1847 he was again chosen church clerk for a year. At that same November 1847 conference he answered the church that he would serve as clerk. But between November and January, something caused Bright change his mind, for at the January 1848 conference, he and his wife requested letters of dismission from Liberty Church, which were granted. One month later, he purchased 80 acres of land from J. P. Thompson, who served as preacher of Liberty Church for many years.

Bright and Sarah's dismission from Liberty Church coincided with their departure from the Bear Creek area where the Mayfields and Breazeals had lived since the mid-1820s. It also coincided with the preparations that Joel M. Breazeal was making to himself leave Tuscaloosa County. He began selling off his plantation in 1846, and he sold the last of his holdings in January 1849 and moved to Pickens County.

Here is a list of the people mentioned in the Liberty Church minutes that are connected to Bright Breazeal:

- Joel Marshall Breazeal: Bright's uncle; Joel M. was the youngest son of Joel and Rebecca Griffin Breazeal.
- Mayfields: All of the siblings of Sarah Elizabeth Mayfield were members of Liberty Baptist Church:
  - Andrew J. Mayfield: See his listing before the transcribed minutes of Sardis above. He was one of the founding members of Liberty Church in 1835. He must have been dismissed from Liberty between 1841 and 1844, but this was apparently not recorded in the minutes.
  - **Arena Amanda Mayfield Pittman:** See her listing before the transcribed minutes of Sardis above. She was one of the founding members of Liberty Church in 1835, but she was excluded from the fellowship of the church in December 1842.
  - Elisha Bennett Mayfield: Born 1820, married Sarah Ann Creel. He lived in Bibb/Tuscaloosa County and died in a training camp in 1861 after joining the Confederate army.
  - Samuel J. Mayfield: Born 1822; he died as a young man in 1840.
  - Jane Adaline Mayfield: Born 1825, married John H. Ward 12 Sept 1841. They lived in the Tuscaloosa County area their entire lives.
  - **Tabitha Ann Mayfield:** Born 1829; married David McDaniel in Saline County Arkansas after moving there to live with her brother Andrew J. Mayfield. She died there in 1866.
  - Talitha Cumi Mayfield: Born 1829 (twin to Tabitha Ann); married Ezekiel N. Lawless in Saline County Arkansas after moving there to live with her brother Andrew J. Mayfield. They later moved to Texas, and she died sometime after 1870.
  - Archibald Pinkney Mayfield: Born 1832, youngest child of Archibald and Tabitha Bennett Mayfield. He moved to Saline County Arkansas with his other siblings in 1844, but was living in Union County in 1850. He moved back to Saline (later Grant) County and had married by 1860. He joined the Confederate army during the war and served as the 2nd Lieutenant in a calvery unit. He spent over a year in a Yankee prison after being captured.
- Cobbs: As mentioned earlier, Azariah and Rosannah Breazeal Cobb were Bright's uncle and aunt. Their daughters Rachel B. and Sarah C. Cobb and son Joel M. Cobb all moved their membership from Sardis to Liberty in the late 1830s or 1840.
- **Asahel (Asa) Lawless:** He was one of the three adult male Lawlesses in the Bear Creek area, but he was not the husband of Nancy Breazeal Lawless. His wife was Agness, who joined at Sardis in June 1828. They were listed on the 1850 census of Perry County Alabama.
- Laura Lawless: I am convinced that she was a half-sister to Bright Breazeal and the daughter of Nancy Breazeal Lawless. Her date of birth was recorded after that of Nancy Breazeal Lawless in the family Bible of Bright Breazeal. She joined Liberty Church at the same time that Caroline, James, and Asahel Lawless did, and also at the same time that Tabitha C., Talitha C., and Archibald Mayfield joined.
- Ezekiel N. Lawless: No proof of his relationship to Nancy Breazeal Lawless is known, but I believe is may be her son. Ezekiel married Talitha C. Mayfield, younger sister of Sarah Elizabeth Mayfield Breazeal. They lived in Saline County Arkansas in 1850, but had moved to Texas by 1860. and later they moved Their eldest child, a male, was named "Hosea B. Lawless" and their next child, a female, was named "Nancy Lawless". This choice of names is striking. However, notice that Ezekiel joined Liberty Church on the same day that Asahel Lawless did.

- Henry Lawless: Relationship unknown; he and Matilda and Primrose Lawless all joined Liberty Church at the same time on the third Sunday of August 1838, the day after Bright Breazeal joined at Liberty.
- Other Lawlesses: The relationship between the following Lawlesses to Nancy Breazeal Lawless is unknown: Matilda Lawless, Primrose Lawless, Henry Lawless, Caroline Lawless, James Lawless. Caroline and James Lawless joined Liberty Church on the same day that Laura Lawless did.

We the undersigned having been Called upon by a number of brethren of the Baptist order and faith living in the neighborhood of Bear Creek In the County & State aforesaid to act as a presbytery in order to look Into their Standing & Constitute them into a church Should they be found orthodox & other Circumstances Should make it proper did meet according to said Call on the Fourteenth day of Nov. 1835 and after an Examination Into the Standing & principles of the Following named Brethren viz: Samuel Mayfield,.... Tabitha Mayfield, Andrew J. Mayfield, Sarah Mayfield, Rebeckah Brezeale, Irena Pitman,.... did proceed to Constitute them Into a Church on the principles and Abstract of faith as published by the Tuscal. Baptist Association & they are hereby vested with full power to exercise all the priveleges which of Right belongs to regular Churches of our faith and order.

- Oct 1837 "A door was opened for the reception of members... J. M. Brazeal and his wife" and "Ataline May-field... were all unanimously recd. on a relation of their experiences."
- July 1838 "Br. Brazeal and Br. Mayfield appointed delegates to association at Friendship Church."
- Aug 1838 "Br. H. B. Brazeal came forward with letter of dismission from Sardis Church and was unanimously recd." On the third Sabbath: Henry Lawless, Matilda Lawless, Primrose Lawless received by experience.
- Oct 1838 Elisha Mayfield received by experience.
- May 1839 "Church then takes up a charge against **Br. Jesse Townsend** for using harsh expressions to **Br. Samuel Tubb. Br. Joel M. Brazeal....**appointed to cite **Br. J. S. Townsend** to attend our next conference that being the time referred to to try to settle the matter."
- July 1839 Matter between **Townsend** and **Tubb** continues. **Br. Brazeal** appointed to cite **Townsend** to attend next conference.
- Aug 1839 **Samuel J. Mayfield** received by experience. **Br. Townsend** excluded from the church. Delegates to the association: **Br. Brazeal**.
- Sept 1839 Asahel Lawless received by experience... "A committee appointed to write to a church in So. Carolina for letter of dismission from that Church he having come without calling for a letter... Ezekiel Lawless came forward and was rec'd." "Nathan, a coloured person belonging to Br. Brazeal came forward and was rec'd."
- Nov 1839 "Joel M. Cobb rec'd. by exp."
- Mar 1840 "Br. Azariah Cobb & wife, Sister Roseann Cobb and Rachel B. Cobb and Sarah C. Cobb, their daughters; by letters from Sardis Church."
- May 1840 "Church then took up a charge against **Br. N. C. Dodson** for forbidding his wife's return which the Church thinks is putting her away and a committee of 5 members were chosen to see **Br. Dodson** to

- wit: Br. Azariah Cobb, Br. Tubb, Br. Brazeal, Br. Mayfield and Br. Hannah."
- June 1840 Dodson matter continued.
- July 1840 Dodson matter continued. J. M. Brazeal, Br. Mayfield, E. S. Dodson, John F. Jolly, and Br. Hannah chosen delegates to the district conference.
- Aug 1840 Dodson matter continued. Delegates to association: **Br. A. Cobb**, **Br. Tubb**, **Br. E. Dodson**, **Br. Brazeal**, alternate.
- Oct 1840 Dodson matter continued. "...went into ordination of two Deacons in this Church...Br. J. M. Brazeal and Br. Azariah Cobb."
- Nov 1840 Br. N. C. Dodson and Sister Martha Dodson both excluded from the church since there was "a pointed contradiction remaining between them."
- Feb 1841 "Br. Henry Lawless having failed to attend conference for several months Church appoints Br. Brazeal and Br. A. Cobb to see him."
- June 1841 "Subject of feetwashing was taken up and laid over till next conference."
- July 1841 "Subject of feetwashing brought before the Church which was decided in the affirmative." Delegates to union meetings: **Br. A. Cobb**, **Br. J. M. Brazeal**.
- Aug 1841 Deletates to association: J. M. Brazeal, A. J. Mayfield. "Meeting protracted. Members received on Wed.: Tabitha Mayfield, Telitha C. Mayfield,... Archibald Mayfield,... Caroline Lawless, Laurah Lawless, James Lawless,... and Asahel Lawless. James Lawless called for letter a few days later."
- Thompson. The clerk to write a letter to Br. Thomson [sic] to notify him of his call from the Church and Br. J. M. and H. B. Brazeal to convey letter to Br. Thompson. Br. Joab Pratt having removed from this vincinity to the State of Arkansas and he having been slandered and as we believe by false accusation between this State and the State of Arkansas. This Church Unanimously concludes to send Br. Pratt's Fair Character and standing from amongst us to that part of the country wherein he stands accused and the church hereby authorises [sic] the Clerk of Liberty Church to assign that instrument in behalf of sd. Church."
- July 1842 Delegates to union meetings: J. M. Brazeal. Delegates to Association: J. M. Brazeal, Elisha Mayfield.
- Aug 1842 "Friday before 3rd Sabbath in Aug 1842. Church met and after prayer and preaching by our beloved **brother Summer** also our beloved brother **Thompson** came into conference.... The subject of feetwashing was taken up and we agree to go into the measure as agreed on in July 1841 and that we attend to the same on tomorrow night at this places (being Saturday before 3rd Sabbath in Aug 1842). Then was offered a letter by **Br. Thompson** from our Sister Church (Mount Pisgah) Six of the members of which requesting that we receive them as under the watch care of the church until they can offer them letters of dismission Mount Pisga [sic] having been duly dissolved for fellowship with us who were unanimously recd. to wit .... also one Colored **brother Moses** belongs to **T. Mayfield...**"
  - "Tabitha Mayfield deceased Wednesday 24 Aug 1842."
- Nov 1842 "Church then resolved to send a request to our sister the Cedar Grove Church to ordain **Br. Burns** and agree to send our request verbally by **Br. J. M. Brazeal** and **Br. E. S. Dodson** at the time of their

next conference."

Dec 1842 "Saturday before the 3rd Sabbath in dec [sic] 1842 Church met and after public worship came into conference.... Br. J. M. Brazeal lays in a charge against our beloved Sister Irena Pitman who had recd. a letter of dismission from this church and had joined a church not of our faith and order – the church therefore took the charge against her and after due investigating the same this church considered it her duty to exclude her from membership.... Br. J. M. Brazeal calls for for [sic] a letter of dismission for our beloved Mother Brazeal and a colored Sister of Mother Brazeal's. Also Br. J. M. Brazeal calls for a letter of dismission for himself and wife all of which were granted."

[Note: "Irena Pitman" was Sarah Mayfield Breazeal's elder sister, Arena Amanda Mayfield Pittman. She and her husband had recently moved to Mississippi. Although Joel M. Breazeal and his wife received letters of dismission from Liberty in December 1842, they apparently turned their letters back in to Liberty between January and June, 1843, for in June 1843 he was appointed to serve on a church committee. However, there is no record of his being received again as a member of the church. His mother Rebecca Griffin Breazeal joined Springhill Church after receiving her letter from Liberty, and she remained a member there until November 1844, when she rejoined at Liberty.]

- June 1843 "A colored brother belonging to Mr. Ward having left his wife and we are informed that he has used ill language. The Church takes up his case against him, and appoint Br. H. B. Committee included J. M. Brazeal.

- Jan 1844 "The Church at Sardis requests the attendance of three members from this Church to sit with them in their next conference on settlement of business which request was granted and the following Br. [sic] were appointed to wit: J. M. Brazeal, R. E. Howard, and E. S. Dodson."
- Mar 1844 "Br. Elijah Clements lays in a complaint against Sardis Church for not having a minute made of a certain act of that church in which he was concerned. and this church agrees to send a committee of five to that church to examine the proceedings and try to counsel on the proceedings whether they be right or not And right sustain her and if wrong admonish her to her duty in the spirit of Meekness. The members thus chosen were J. M. Brazeal, H. B. Brazeal, E. B. Mayfield, E. S. Dodson, and R. E. Howard."

Sabbath in Nov. next to assist in the establishment of sd. arm to wit: E. S. Dodson, J. M. Brazeal, R. E. Howard, William Deason, E. B. Mayfield, Vincent King, H. R. Hannah, H. B. Brazeal, M. Self."
- Nov 1844 "Mother Rebecca Brazeal requests to join this Church on a letter of dism. from Springhill Church, but said letter of dism. being mislayed, Church unanimously receives Mother Brazeal and br. J. M. Brazeal will either get the letter which is mislayed or another letter from sd. Church and hand to this Church some time in the future. Committee on South Sandy arm not ready to report; laid over. Br. J. P. Thompson chosen Moderator and Br. Howard clerk for ensuing year. J. M. Brazeal and E. S. Dodson appointed to inform Br. Thompson of his call... Church takes up a charge against Br. James Lawless, Jr. for immoral conduct and Bros. J. M. Brazeal, E. S. Dodson, and E. B. Mayfield..." appointed to cite him. "J. M. Brazeal, E. S. Dodson, and E. B. Mayfield appointed to examine Church book and report at next conference."
- Dec 1844 "Committee on South Sandy arm reports arm established at Union meeting house.... Br. James Lawless not being present his case continued and Br. H. B. Brazeal appointed to cite him to attend next conference."
- Jan 1845 "References: Case of **James Lawless**, **Jr.** Exonerates himself by saying that the report of having used ill language is not correct. Church acquits."
- Feb 1845 References J. J. Jolly case continued; A. Lawless to inform him of same. Letter of dismission: Henry Lawless.
- Mar 1845 References: J. J. Jolly case again continued. J. M. Brazeal appointed to cite him.
- Apr 1845 "Saturday before 3rd Sabbath in Apr. 1845. Church met and after public worship came into conf.... The church takes up a charge (vs.) **brother John Bracknell** for having used slanderous language (vs.) a personage [sic] in the bounds of church and it being of a public nature the church agrees to appoint a committee and converse with him and request his attendance at next conference also to report at next conference committee as follows to wit **J. M. Brazeal**, **E. S. Dodson**, **Middleton Self**, **Hiram White**, **H. B. Brazeal**..."
- May 1845 "Saturday before 3<sup>rd</sup> Sabbath in May 1845 Church at Liberty met and being no minister present called conference.... J. M. Brazeal, Moderator.... References called for which brings before the church the case of br. John Bracknell the committee which was apointed [sic] to cite br. Bracknel reported to church and the church receives report and discharges committee. The church takes up the matter and br. Bracknel states that if he said anything like the language refered to by several brethrin [sic] that he had no cause and that if he did he has forgotten it and that if he did so that he is truly sorry for it and that he has no remorse of feeling (vs.) the brethren who heard him use the language refered to. The church on his acknowledgement agrees to restore Br. Bracknel to fellowship..."

McDowell for a charge of intoxication and also for the use of improper language. The church ap [sic] a committee to see and cite him to our next conference as follows J. M. Brazeal and E. S. Dodson..."
- July 1845 "Saturday before 3<sup>rd</sup> Sabbath in July 1845 Liberty Church met and after Preaching by **Elder Joab Pratt** and **br. Thompson** came into conference.... References called for which brings before the church from our last conference the case of **br. Ja. Lawliss Junr.** committee reports report recd. committee discharged. The church takes up the case and on investigating the matter the church thinks it duty to exclude him. He is therefore excluded.... **Br. H. B. Brazeal** is appointed to call on **br. James Lawless** for his church..."

Delegates to Union Meeting: J. M. Brazeal, E. S. Dodson, E. B. Mayfield, and H. F. Hannah. Delegates to Association: R. E. Howard, J. M. Brazeal, E. S. Dodson, and H. F. Hannah as alternate.

- Aug 1845 "Saturday before the 3rd Sabbath in Aug. 1845 Liberty Church met and after public worship came into conference.... Appointed Br. Edwin Mitchell Moderator.... References called for which brings before the church the case of brother Lawless Junr. he being ixcluded [sic] at our last conference and br. H. B. Brazeal being appointed to call for his letter brings forward the letter from br. Lawless.... General businiss [sic] called Br. Ely Hughs presents a petition from Union Church (arm of this church) for letters of dismission from this church to try to go into a constitution on Saturday before the fifth Sabboth [sic] in this inst. the letters are granted and the following br. to go to that church at that time and if they cannot complete their desires the brethren to return their letters to this church again as follows the brethren to go from this church are br. J. M. Brazeal, H. F. Hannah, E. S. Dodson, H. B. Brazeal, Wm. McDowell, John Shuttlesworth, V. King Then conference closed."
- Jan 1846 "Saturday before 3rd Sabbath in Jan 1846 Church met pursuant to adjournment No preaching came into conference.... Appointed **br. J. M. Brazeal** to act as moderator.... References from last conference was taken up and called **br. J. P. Thompson** as a supply in the ministry and appointed **br. H. B. Brazeal** and **E. B. Mayfield** to notify **br. Thompson** of his call.... General businiss [sic] called for **br. E. S. Dodson** calls for letter of dism. it was granted..."
- Feb 1846 "Saturday before 3rd Sabbath in Feb. 1846 Church met and after prayer by **br. J. M. Brazeal** came into conference.... **Br. J. M. Brazeal** appointed Moderator.... References called for.... The committee which was appointed at our last conference to see and notify **br. J. P. Thompson** of his call by this church to serve us this year in the ministry made their report that they had not seen **br. Thompson** Therefore sd. committee is continued to see **brother Thompson** and hand a letter to him which is to be written to him in behalf of the church by **br. J. M. Brazeal** and to report to our next conference. Conference closed."
- Mar 1846 "Saturday before 3rd Sabbath in march [sic] 1846 Church met and after preaching by br. J. P. Thompson came into conference.... References called for and the church takes up the reference of appointing another deacon whereupon br. R. E. Howard was appointed and the church then agrees to solicit br. J. P. Thompson, br. Oswalt, br. Meek, and br. Bridston to attend at the time of our next conference to assist in the ordination of a deacon in this church.... The church then calls for the reference of a call in the ministry and br. Thompson answering this church that through the Mercy of God he will try to serve this Church this year in the Ministry.... br. John Shuttleworth states that he has got into a difficulty with J. H. Ward of Sardis Church the church condems the course of br. Shuttlesworth he says he is truly sorry for the difficulty but as the matter cannot be settled to day [sic] She appoints a committee consisting of br. J. M. Brazeal, br. Middleton Self and br. Henry F. Hannah to labor with br. Shuttles [sic] and br. Ward and to report the fruit of their labor at

next conference..."

[Note: "J. H. Ward" was John H. Ward, the husband of Sarah Mayfield Breazeal's sister Jane Adaline Mayfield Ward.]

- Apr 1846 "Saturday before 3rd Sabbath in Apr. 1846 Liberty Church met pursuant to adjournment and after prayer and preaching by **Thompson** church came into conference.... References called whereupon the church takes up the subject of the ordination of a deacon but the ministry who were solicited failed to appe [sic] and the church continues the case till our next conference and continues the same committee with the addition addition [sic] of br. E. B. Mayfield with instructions to solicit the same preaching br. with the addition of br. Samuel Raglin. The church takes up the reference on the subject of difficulty between br. John Shuttlesworth and br. John H. Ward. The committee failed jointly to see them but br. J. M. Brazeal saw and conversed with them but he states that he thinks that he affected but little. The parties being present state that they had conversed with each other but had not reconciled the matter. The church advises the brethren to converse again this evening upon the matter and that our Moderator, the same committee with the addition of br. Thompson, br. V. King and **Hughs** and **Howard** be present and try to effect a settlement this evening and to report on tomorrow. The br. all attended according to appointment and after talking their difficulty all over the Moderator advises the brethren to lay the matter down to which the brethren assent to lay it down and gave each other their hand as a manifestation of the same and of friendship. This is the report of committee."

Oswalt**.... the brethren who were solicited to attend as a presbyty attended (to wit) **br. Oswalt** and **br. Boidston** and they with our br. moderator went into the ordination of **br. References called for which brings before the church the case of reference from last conference against **sister Hughs** for fornication the committee reports that they got information in the matter sufficient to convince them of her guilt the committee asks to be discharged The church discharge [sic] them and takes up the matter against Sister and after satisfaction in investigation she is excluded.

- Aug 1848 "Liberty church met pursuant to adjournment prayer and preaching by Revd. (?) Wm S. Meek then came into conference. 1. Apointed [sic] Revd S. Meek Moderator and R. E. Howard Clerk of the committee Chosen to assist in settling the difficulty between Br. E. B. Mayfield and br. Samuel Shuttlesworth. The church chooses br. Vincent King, Br. Edwd Deason and br. Simon Brown to act with the helps from their Sister churches in trying to settle the difficulty between the above named brethren. The case between them was called and the committee or helps a majority of them say that we acquit Br. E. B. Mayfield of the charge which was ehibited (?) (vs) him by Liberty Church. The committee then asked to be discharged they were discharged accordingly. General business elicited. The church then goes into the choice of deligates to the association and district meetings whereup Br. Vincent King, Howard, Brazeal and Hubbard were chosen to district meeting and br. Howard, br. King and br. Self and br. Brazeal in case of failure to the association..."
- Oct 1848 "October Term Liberty Church met pursuant to adjournment Prayer by br. Howard them came into conference.... General business called for. [the following requested letters of dismission] Sister Susannah Deason, R. E. Howard, br. Middleton Self, Sister Phebe Self, br. Henry Self and br. Alexander (colored br. of br. Selfs) also Washington M. Howard, John J. Howard, Nancy E. Howard, Ruthy Dodson, Jesse Dodson, Sister Permelia Brazeal and Nathan and Lizza, colored br. and Sister of br. J. M. Breazeals were all granted. br. J. M. Brazeal applies for a letter of dismission but there being a report in circulation that br. Brazeal had been intoxicated and the church takes up (vs) Br. J. M. Brazeal by report and appoints br. Stephen Hubbard to see br. J. M. Brazeal and request his attendance at next conference...."
- Nov 1848 "Nov. Term Liberty Church met pursuant to adjournment.... References called for which brings before the church the case of **br. J. M. Brazeal** had been overtaken in the fault of having drank too much spirits; the church defered [sic] granting his letter till the present conference. And **br. Brazeal** being now present and states that he did drink too much and that he is truly sorry for the same and asks that the church should forgive forgive [sic] him which they cordially did. And then grants **br. Brazeal** a letter of dismission.... The church then goes into the choice of a clerk and appoints **br E. B. Mayfield...**"
- Dec 1848 Church chose Br. Boidston pastor, E. B. Mayfield to write to Br. Boidston.
- Aug 1849 District delegates: E. B. Mayfield; Assoc. delegates: E. B. Mayfield

General business caled [sic] for The Church appoints a commity [sic] to visit her Absent members to viz **Brethren Brown, Young, Hughes, Jolly, Carrol, Deason** and **Saml Shuttleworth** and Site [sic] them to her next conference to state the reason of there [sic] non attendance. the commity [sic] consists of **Br. King, Allan** and **Mayfield**. Conference Closed."

Hughs** is present the Church continues the case tel [sic] next conference In order to procure testimony. **Br. Mayfield** to attend to it...."
- May 1850 "May Term 1850 Saturday before the 3<sup>rd</sup> Sabbath in May 1850 Liberty Church met and after Preaching by **Br. Creel** came into conference.... The church takes up the case of **Br. Hughs** and after talking on the case continued the same til next Conference. **Br. Mayfield** to procure testimony."
- June 1850 "June Term 1850 Saturday before the 3rd Sabbath in June Church met and after preaching by Br. Creel came into conference.... Caled [sic] for references then takes up the case of Br. Hughes and upon his Acknowledgements the Church forgave him.... Br. Mayfield came forward with a complaint against him self for quarreling and proposing to fight and upon his acknowledgement the Church forgave him.... on acounts [sic] of a dificulty [sic] existing between Br. R. E. Howard and Mayfield Br. Howard came to this church and the church refused to take the matter on account of not seeing how to settle the same and Sardis church sent a committee to this church and the Difficulty was Amicably settled between the Brethren."
- July 1850 "July Term Saturday before the 3rd Sabbath in July 1850 Liberty Church met and after preaching by **Br. F. Creel** came in Conference.... The Church agrees to Make up a small amount of money and appoint a committee of two Members to assist **Br. Creel** in getting some books and to visit Macedonia for her assistance the committee is **Br. Wm. W. Allen** and **E. B. Mayfield**."
- Aug 1850 ".... Church agrees to send for **Br. J. J. Jolly** for not attending conference. **Br. Brown** and **Mayfield** to site him to next conference."
- July 1851 District delegates: E. B. Mayfield; Assoc. delegates: E. B. Mayfield
- May 1852 Letters granted: E. B. Mayfield and wife. "T. E. Allen appointd [sic] clerk."
  - 12.3. Union Baptist Church, Hale County Alabama. Hosea B. and Sarah E. Breazeal remained in Tuscaloosa County for ten years following their dismissal from Liberty Baptist Church in January 1848. Their dismission from Liberty coincided with their move from the old plantations of Joel Breazeal and Archibald Mayfield northwest about ten miles to a location in south central Tuscaloosa Co AL. Their new location was closer to Union Baptist Church, which Bright had helped form in 1845 as an "arm" of Liberty Church. Sarah's brother Elisha Bennett Mayfield is known to have been a member at Union during the 1850s, and Mayfield's wife Sarah Ann Creel Mayfield joined Liberty from Union in December 1846.

Since their church was clearly important to Bright and Sarah, it seems quite likely that they would have remained members of some church, and Union is the most likely candidate. However, the minutes of this church have not been located.

12.4. Caledonia Baptist Church, Union County Arkansas. Bright and Sarah Breazeal arrived in the vicinity of south Arkansas in late 1857 or early 1858. They apparently first lived in northern Union Parish Louisiaia, but by early 1859 they had settled on farm adjoining those of Sarah's brother Andrew J. Mayfield and Bright's uncle and aunt, Azariah and Rosannah Breazeal Cobb. The lived in the community of Caledonia, just a few miles north of the Louisiana border in Union County Arkansas. The Mayfields and Cobbs, along with Elder Joab Pratt, were founders of the Caledonia Baptist Church in southern Union County. It seems quite likely that Bright and Sarah were members there for the 8 or 9 years they lived in that area, 1858–1867. However, so far the minutes of this church have not been located.

12.5. New Hope Primitive Baptist Church, Union Parish Louisiana. Hosea Bright Breazeal and his descendants have been associated with New Hope Primitive Baptist Church since he joined the church on 10 August 1872. His son Hosea W. Breazeal and daughters Sarah A. E. Ogden and Laura Agness Sumners were members of New Hope, and numerous grandchildren and great-grandchildren have been members of, pastors of, or clerks of New Hope Church in this century.

This church is located just north of Spearsville, Louisiana. It was formed sometime before 1856, when the earliest recorded member, **Alexander Wilson Upshaw**, joined the church. The surviving church minutes date from 8 Oct 1870, and they are held by the clerk of the church.

Hosea B. Breazeal joined New Hope Church on 10 August 1872 and was a member there for fifteen years. There is no record of Sarah ever being a member. She possibly was a member of another church, perhaps a Missionary Baptist Church, but no record of this has been found. She was apparently not a member of the Spearsville Baptist Church as her name has not been found in the minutes of that church.

There are several loose pages in the earliest extant minutes book which contain the names of the members of New Hope Primitive Baptist Church. There is duplication between these pages, for the two Breazeal members before 1890 are recorded twice:

"H. B. Brazeal (also Brazzel), by confession August 10, 1872; Excluded Nov. 12, 1887" "H. W. Brazeal (also Brazzel), by Exc. Nov. 9, 1878; Excluded Nov. 12, 1887"

Unlike the churches Bright Breazeal belonged to in Tuscaloosa Co AL, New Hope was a Primitive Baptist Church, and thus did not believe in missions. The Tuscaloosa Co AL churches were not strongly for or against missions until after Hosea left the church, although they began to lean towards missions in the mid 1840s. However, Hosea joined New Hope Church "by confession of faith", meaning he had previously belonged to a Primitive Baptist Church, but must have failed to obtain a letter of dismission from the previous church since he did not join New Hope "by letter."

12.5.1. Clerk of New Hope Church. Bright Breazeal was the clerk of New Hope Primitive Baptist Church from 10 April 1880 until 12 Nov 1887. Joseph R. Goyne was the clerk of New Hope Church when the earliest minute book was started in 1870, and he continued serving as clerk until his death in February 1880. Following Breazeal's exclusion from New Hope, N. B. Bird, Jr. was chosen clerk, and he served for most of the next twenty years. However, for several of those years, Hosea W. Breazeal served as temporary clerk and recorded the minutes of the church.

Goyne was a businessman and store owner, and was educated and well-read enough that his spelling in the church minutes was always correct. However, it is apparent that Goyne made his entries in a hurry, as they are often written so sloppily that they are hard to read. ¿From his recording of the minutes between 1888 and 1910, Bird was educated enough that his spelling was always precise by modern standards, and, moreover, his handwriting was beautiful.

In contrast, Bright Breazeal's spelling was quaint and his handwriting appears labored and often hard to read until one adjusts to it. Breazeal had an education, for he was a justice of the peace in both Alabama and Louisiana and was the church clerk of at least two churches. However, he must not have been as well-read as Goyne (which is to be expected since Breazeal was a farmer and not a businessman), for often his spelling of words is amusing. He wrote "Devine", "viseting", "Breatheren", "miselanous Buisnes", "Newhop", etc. However, Bright Breazeal seemed to take much greater pains in recording the minutes than Goyne did.

At the beginning of the earliest extant minute book is recorded the "Rules of Decorrum [sic] of Newhop [sic] Church", written in the handwriting of Bright Breazeal and signed as "H. B. Brazeal, Church Clk." Following this, the "Articles of faith" are recorded, again in Breazeal's handwriting, and again signed as "H. B. Breazeal, Clk." Neither of these records are dated. Following the rules of decorum and the articles of faith, the church minutes beginning in 1870 are recorded. Bright Breazeal must have written these records in the front of the minute book while he was clerk, between 1880 and 1887.

12.5.2. Controversy. During the year 1887 or earlier, a controversy arose within New Hope Church and perhaps other Primitive Baptist churches that caused serious problems for many years. Apparently four male members of the church joined an organization called the Farmer's Union. Part of the Primitive Baptist faith is that secret institutions and organizations are not scriptural, and those in fellowship with a Primitive Baptist Church are not allowed to belong to such "worldly institutions". This also includes temperance societies, Bible study groups, etc.

Apparently, sometime in mid-1887, Bright Breazeal, his son Hosea W. Breazeal, W. H. Risinger, and J. M. Morris joined the Farmer's Union. The first indication of trouble is that no conference was held in June 1887, the first time in at least seventeen years that New Hope Church failed to hold a conference in the month of June. At the July conference, the peace and fellowship of the church was called for and the moderator protem, N. Bird, Sr., made a motion that the question be postponed until the next conference. The August conference was not held since the church was "out of order". The September meeting was the usual time for the District Meeting to be held at New Hope Church, but due to the church being in "Disorder an [sic] No peace", it was dismissed. Similarly, there was no conference held at the October meeting for the same reason.

Things reached the boiling point at the November conference. Bright Breazeal, his son Hosea Woodford Breazeal, W. H. Risinger, E. Risinger, J. M. Morris, M. A. E. Morris, and E. C. Post were excluded from membership of New Hope Church on 12 November 1887 over the membership in the Farmer's Union of the Breazeals, Morris, and Risinger. Those who were excluded constituted one-half of the total membership of the church at that time.

The vote of the church regarding the exclusions is rather confusing. The names of the members voting and how they voted is recorded in the minutes. Following the vote, the minutes read "The church being thus divided (seven against six) it was declared by the majority that they were the church of Christ and therefore claimed the house and all things pertaining thereto." Seven members voted against holding fellowship with those who belonged to the Farmer's Union, i.e., they voted to exclude them from the church. However, the number of members voting for fellowship was also seven, so why did the minutes say the vote was seven against six? The answer probably has something to do with W. H. Risinger. He voted for fellowship, but his name was clearly added to the minutes at a later time; it was written above the others with an arrow. Could he have been absent from the conference?

Judging from the minutes, this controversy nearly destroyed the church. Between 1870 and 1887, monthly conferences and meetings occasionally were not held during periods of inclement weather or perhaps due to the lack of a pastor. Usually such instances were during the winter, when bad weather is more common. For example, no conferences were held in either December 1885 or the next month in January 1886, probably due to inclement weather.

However, following the Farmer's Union exclusions in November 1887, New Hope Church had no meetings in December 1887, nor was conference held in February, March, April, May, or June 1888. In fact, in the year following the exclusions, New Hope only held six conferences. A similar pattern developed for the next several years. Conferences were not again held at New Hope Church on a regular basis for five years, beginning in April 1893. Based upon how regular conferences were held prior to November 1887, it would appear that the Farmer's Union exclusions caused very serious problems for New Hope Church for more than five years.

The next conference following the exclusions was held on 7 January 1888, and the church authorized the new clerk N. B. Bird, Jr. to record the minutes of the previous November conference in the "Church book." The matter was serious enough that the church asked a committee of preachers, Elders J. E. Knighten, Henry Archer, and R. M. Gathright, to examine the actions of the church in the exclusions. On 9 March 1889, they made a resolution that was endorsed by New Hope Church that they "find that the course of the church in excluding.... was scriptural and right..."

The next development took place on 13 September 1890, when John M. Morris, one of the Farmer's Union members who was excluded along with the Breazeals, came forward during the conference and "made acknowledgements" and was restored to membership of New Hope Church. Morris' wife M. A.

E. Morris had also been excluded with him, but she did not apologize to the church and so remained excluded from fellowship.

As stated above, conferences once again were held on a regular basis beginning in April 1893. On Tuesday, 29 August 1893, following the District Meeting held at New Hope, the church held services followed by conference. The preaching was by Elders T. J. Foster, M. W. Hux, and W. K. Smith. Smith had been the pastor of New Hope from 1883 until 1888, and the District Meeting the previous weekend is the first record of his preaching at New Hope since 7 July 1888. As usual during the conference, the church opened the doors of the church for the reception of new members, and

Sisters E. C. Post, Emiline Risinger, M. A. E. Morris & W. H. Risinger who was [sic] Illegally & unscripturaly [sic] Excluded on the 12 day of Nov 1887 Restord [sic] to the full fellowship of the church By Bro. N. B. Bird Sr. acknowledging his wrong in the exclusion [emphasis added].

So after nearly six years, Bright Breazeal was redeemed. Too bad he did not live to see it, for he had died two years earlier, on 19 October 1891.

The remaining excluded member not yet restored was Hosea W. Breazeal. He did not ask to be restored until 27 November 1897, fully ten years after the exclusions first took place.

The Farmer's Union controversy was thus resolved at New Hope Church, but it was not completely resolved among other Primitive Baptist Churches. On 23 August 1896, Elder Smith requested that New Hope Church extend an "arm" to the Nash school house in Union County Arkansas, which the church did. Then on 26 September 1897, several members of New Hope asked to be dismissed to constitute a church at the Nash school house, including Bright Breazeal's daughter Sarah A. E. Breazeal Ogden and her husband, William R. Ogden. The church was constituted on 2 October 1897 and was called Smyrna Church. At the 1906 District Meeting held at New Hope Church, Smyrna sent two "factions" to represent the church: the Farmer's Union faction and the "other" faction. The district meeting rejected the Farmer's Union faction, and Woodie K. Smith was authorized to write the Farmer's Union faction of Smyrna about their rejection. Bright Breazeal's son-in-law William R. Ogden was one of the deligates to the district meeting from the non-Farmer's Union faction of Smyrna Church.

12.5.3. Woodie K. Smith and the Exclusions. It is interesting to observe the change in pastors of New Hope Church following the Farmer's Union exclusions. Woodie K. Smith is first mentioned as preaching at New Hope Church in August 1882. Smith was called as the pastor of New Hope Church for the next year, 1883, and he continued serving as pastor of New Hope through 1887. Smith preached in the services held before the November 1887 exclusions, but he was not present for services for the next month, nor was he at the January 1888 conference. The church did call Smith as the pastor for 1888, although there is no record that he accepted. Smith preached at New Hope on 9 June 1888, but no conference was held that day. He also preached there the next month on 7 July, followed by conference. However, he missed the August, September, October, and November conferences, and in December, Elder Gathright was called to serve the church for 1889.

Perhaps the most telling indication of Smith's opinion of the controversy was his absence from the committee of preachers called upon by New Hope Church in March 1889 to examine the action of the church in the Farmer's Union exclusions. The preachers on the committee were Knighten, Archer, and Gathright. As Smith had been pastor of New Hope Church for five years prior to the exclusions, and so had served as pastor during the time the controversy was brewing, it would certainly seem appropriate for him to be on the committee. Does his absense from it indicate he disagreed with the exclusions?

Following his sermon delivered on 7 July 1888, Smith was not again mentioned in the minutes as preaching at New Hope Church until the district meeting held there in August 1893. He again preached at New Hope the following October, and beginning in February 1895, Smith frequently preached at New Hope. Throughout this period, Elder R. M. Gathright was the pastor of New Hope Church. In February 1896, Gathright asked to be released from serving the church since his time was filled with other churches and Smith lived much closer to the church. Smith was chosen pastor, and he served for many years.

Woodie K. Smith's five year absence from the pulpit of New Hope Church ended on Friday, 25 August 1893, the beginning of the district meeting held at New Hope. The following Tuesday, Smith preached

before New Hope held the conference in which the Farmer's Union exclusions were described by the church as illegal and unscriptural.

I believe that all of these facts taken together strongly suggest that Smith disagreed with the Farmer's Union exclusions, and explain why he had little or nothing to do with New Hope Church until they were revoked.

12.5.4. New Hope Church Minutes. Below are abstracts of all entries involving Bright Breazeal and his family in the first minute book, which dates from 1870 until 1912. The entries are listed by date with the page numbers given. Besides Bright and his son Hosea W. Breazeal, Bright's daughter Sarah Ann Elizabeth Breazeal Ogden and her husband William R. Ogden joined the church in 1896, his daughter Laura Agness Breazeal Sumners and daughter-in-law Angelina Williams Breazeal joined in 1901, and his grandson William Groves joined in 1907. Numerous other grandchildren and other descendants joined New Hope Primitive Baptist Church in later years, and his descendants are still members of this church today.

Besides entries of Bright and his family, many entries following the Farmer's Union exclusions on 12 November 1887 are transcribed to illustrate the drastic effect this exclusion had on the church.

The minutes have been transcribed exactly as originally written, with no attempt to correct spelling or punctuation. Obvious spelling or grammatical errors are followed by the usual "[sic]". A serious problem with reading Bright Breazeal's handwriting is that often one cannot determine whether a word is capitalized or not. In many cases it is impossible to tell whether a "c" or an "s" is supposed to be capitalized or lower case. I have used my judgement in transcribing such cases, and due to the large number of them, I do not use "[sic]" following capitalization errors. The clerks sometimes used the abbreviations "M.D." or "Mod." for "Moderator" and "C. Ck" for "Church Clerk".

[Note: The above entry was not in Breazeal's handwriting, but in the writing of the church clerk **Joseph R. Goyne**. Goyne was apparently absent from church conference and Breazeal had been chosen "clerk protem", or temporary clerk.]

Primitive Baptist Association convened with New Hope Church on on [sic] Friday July 10<sup>th</sup> 1874. After divine services by **Elders Archer** & **Bro. Dean** Proceeded to Organize by **Bro. Archer** acting as MD & **J. R. Goyne** Clk. the delegates not all being Present it was Moved Seconded that the business of district Meeting be put off till tomorrow. Saturday July 11<sup>th</sup>. After Divine Services Proceeded to attend to the Business of the district Meeting. Letters being called for from diferent [sic] churches letters from the following churches were Presented with the following delegates...New Hope **Brethren A. W. Upshaw, N. Burd** [sic] **J. R. Goyne** & **H. B. Brazzel** Alternate....it was moved & second & carried that our next district meeting be Held with Good Hope Church Union County Arkans. Friday before 1st

[Note: The 9 Aug 1879 conference minutes is the last entry recorded in the minute book in the handwriting of Joseph R. Goyne, although he continued to serve as clerk until his death in February 1880. The conference minutes from 13 Sept 1879 through 8 Oct 1887 are recorded in the handwriting of Bright Breazeal, who followed Goyne as clerk. Although Goyne failed to record the minutes between September 1879 and January 1880 before his death in February, he served as clerk for each of these conferences except the one in December. For many of these conference minutes, Breazeal signed Goyne's name as the clerk, but initialed the entries, apparently to indicate he was the one recording them in the church minutes book. ]

Jan-Apr 1907 **H. W. Breazeal** served as the "clerk protem" for the conferences held in January, February, March, and April 1907, but the entries were recorded in the church minute book by the clerk, **N. B. Bird, Jr.**.

1907–1910 **H. W. Breazeal** served as the "clerk protem" of New Hope Church during this period, and all entries in the church minute book are recorded in his handwriting. It is remarkably similar to the handwriting of his father, **Hosea B. Breazeal**. The exact meetings days during this period are given below.

Nov, Dec 1909 and Jan 1910: Conference held.

Feb 1910: No preaching.

Mar 1910: Conference held.

Apr 1910: Preaching on Sunday.

May 1910: Conference held.

June 1910: No meeting.

July, Aug, Sept 1910: Conference held.

Oct 1910: No meeting.

Nov 1910: Conference held.

[Note: The November 1910 conference minutes is the last entry in this minutes book recorded in the handwriting of H. W. Breazeal. He had been serving as temporary clerk for over three years. The following minutes were recorded in the handwriting of the clerk, N. B. Bird, Jr., who now apparently began attending church regularly again.]

Dec 1910 "Preaching, but no conference."

17 June 1911 Page 215. Messingers [sic] to the District Meeting at Smyrna: W. A. Groves, H. W. Breazeal.

16 Sept 1911 Page 216.

"Called for the peace of the church.... As **brother H. W. Breazeal** had missed two meetings in succession and it was stated that he was hurt with **Eld. W. K. Smith** for telling **Mr. Jno. Barron** and wife a slandrous [sic] report on the latter's wife, etc., which one **Henry Williams** had circulated and that he (**Bro. Breazeal**) required an acknowledgment from **Eld. Smith**; hence the church was not in peace...The church appointed **Eld. N. B. Bird, Jr.** and **Bro. Wood** a committee to see **Bro. H. W. Breazeal** and ascertain the \_? of the trouble existing on his person and **Bro. Smith**..." Delegates to the association: **W. A. Groves**, alternate.

Nov 1911 "the committee appointed to see **Bro. H. W. Breazeal** reported that he was not reconciled to **Eld. W. K. Smith** on account of a slanderous report on the wife of **Mr. J. A. Barron** being carried to them

(Barron and wife) by Bro. Smith. He <u>?</u> no reconciliation. Bro. J. P. Wood and myself agreed to see Bro. Breazeal again and bring about reconciliation if possible, and cite him to the church. Bro. Smith also demanded personal explanation.

Jan 1912 "...the report of myself about **Bro. Breazeal** and **Bro. (Eld.) Smith**. The report was as follows: **Bro. Smith** and wife and **Bro. Breazeal** and wife had been induced to sign a peace proposition to the effect that each one forgive, look over, etc., the wrongs done by the others and <u>all</u> be as one in peace again in the church and neighborhood. Each family kept copy of the said peace proposition. The church rendered no objections to this; hence it is dropped with satisfaction.
